HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

HB18-1181 be amended as follows:

- 1 Amend printed bill, page 3, line 6, after "A" insert "NATURAL".
- 2 Page 3, line 20, after "(2.5)" insert "(a)" and after "ANY" insert
3 "NATURAL".
- 4 Page 3, line 21, strike "SECTION 32-1-103 (5)(f)" and substitute "SECTIONS
5 32-1-103 (5)(f) AND 32-1-806.5".
- 6 Page 4, line 3, strike "COLORADO." and substitute "COLORADO BUT I AM
7 A RESIDENT OF THE STATE OF _____, COUNTY OF _____, AND AM AN
8 ELIGIBLE ELECTOR IN THE STATE OF _____."
- 9 Page 4, after line 17 insert:
- 10 "(b) IN ORDER TO VOTE IN A SPECIAL DISTRICT ELECTION IN
11 ACCORDANCE WITH SECTION 32-1-806.5, THE SELF-AFFIRMING OATH OR
12 AFFIRMATION REQUIRED BY SUBSECTION (2.5)(a) OF THIS SECTION MUST
13 BE NOTARIZED BY THE ELECTOR."
- 14 Page 5, strike lines 1 and 2 and substitute "**district election - option for
15 special district to allow owners of taxable property within special
16 district who are not state residents to vote for district board
17 members.** (1) ANY SPECIAL DISTRICT ORGANIZED UNDER THE LAWS OF
18 THE STATE MAY, UPON PASSAGE OF A RESOLUTION BY THE BOARD OF THE
19 DISTRICT, ALLOW AN ELECTOR WHOSE ELIGIBILITY TO VOTE IN A SPECIAL
20 DISTRICT ELECTION IS ESTABLISHED BY SECTION 32-1-806 (2.5) TO VOTE
21 FOR CANDIDATES FOR THE BOARD OF DIRECTORS OF THE SPECIAL DISTRICT
22 IN ACCORDANCE WITH THE REQUIREMENTS OF THIS SECTION. SUBJECT TO
23 THE REQUIREMENTS OF THIS SECTION, NO PERSON WHO IS DESIGNATED".
- 24 Page 5, line 7, after "REGISTRATION." add "NOTWITHSTANDING ANY
25 OTHER PROVISION OF THIS SECTION, THIS SECTION ONLY APPLIES TO A
26 SPECIAL DISTRICT WHOSE BOARD OF DIRECTORS, BY RESOLUTION, PERMITS
27 AN ELIGIBLE ELECTOR WHO IS NOT A RESIDENT OF THE STATE TO VOTE IN
28 ELECTIONS OF THE SPECIAL DISTRICT IN ACCORDANCE WITH THE
29 REQUIREMENTS OF THIS SECTION."
- 30 Page 7, line 3, strike "(3.5)." and substitute
- 31 "(3.5); AND
32 (c) SUBMIT A COPY OF THE NOTARIZED SELF-AFFIRMING OATH OR

1 AFFIRMATION THE ELECTOR HAS EXECUTED PURSUANT TO SECTION
2 32-1-806 (2.5).".

3 Page 7, after line 12 insert:

4 "(d) THE ELECTOR'S STATE AND COUNTY OF RESIDENCE AND
5 WHETHER THE ELECTOR IS AN ELIGIBLE ELECTOR OF THE STATE
6 IDENTIFIED.".

7 Reletter succeeding paragraphs accordingly.

8 Page 8, line 8, strike "(7)(g)" and substitute "(7)(h)".
