Committee on Education.

HB25-1278 be amended as follows:

- 1 Amend printed bill, page 6, line 26, after "(2)(c)(IV)" insert "and (3)".
- 2 Page 7, line 1, strike "- rules." and substitute "- **accountability work**
- 3 **group - rules.**".
- 4 Page 8, after line 1 insert:
 - 5 "(3) (a) THE DEPARTMENT SHALL CONVENE AN ACCOUNTABILITY
 - 6 WORK GROUP TO PROVIDE FEEDBACK TO THE DEPARTMENT RELATED TO
 - 7 STATE AND FEDERAL ACCOUNTABILITY POLICIES AND DECISIONS AND TO

 - 13 SUPERINTENDENT WHO REPRESENTS A RURAL SCHOOL DISTRICT;
 - 14 (II) FIVE MEMBERS WHO SERVE AS SCHOOL AND SCHOOL DISTRICT
 - 15 LEADERS;
 - 16 (III) ONE MEMBER WHO SERVES AS A CHARTER SCHOOL LEADER;
 - 17 (IV) ONE MEMBER WHO WORKS FOR A BOARD OF COOPERATIVE
 - 18 SERVICES;
 - 19 (V) ONE MEMBER WHO REPRESENTS A STATEWIDE ORGANIZATION
 - 20 SERVING SCHOOL EXECUTIVES;
 - 21 (VI) ONE MEMBER WHO REPRESENTS A STATEWIDE ORGANIZATION
 - 22 REPRESENTING LOCAL SCHOOL BOARDS;
 - 23 (VII) ONE MEMBER WHO REPRESENTS A STATEWIDE
 - 24 ORGANIZATION REPRESENTING EDUCATORS;
 - 25 (VIII) TWO MEMBERS WHO REPRESENT AN EDUCATION ADVOCACY
 - 26 ORGANIZATION OR A CIVIL RIGHTS ORGANIZATION; AND
 - 27 (IX) ONE MEMBER WHO IS A PARENT OR WHO REPRESENTS AN
 - 28 ORGANIZATION FOCUSED ON FAMILY INVOLVEMENT IN EDUCATION.
 - 29 (b) THE MEMBERS OF THE ACCOUNTABILITY WORK GROUP SHALL
 - 30 SERVE AT THE WILL OF THE COMMISSIONER AND SHALL NOT RECEIVE
 - 31 COMPENSATION OR REIMBURSEMENT FOR EXPENSES.
 - 32 (c) THE DEPARTMENT SHALL CONVENE MEETINGS OF THE
 - 33 ACCOUNTABILITY WORK GROUP AS NECESSARY AND WITHIN EXISTING
 - 34 APPROPRIATIONS.
 - 35 (d) THE ACCOUNTABILITY WORK GROUP MEETINGS ARE OPEN TO
 - 36 THE PUBLIC."

13 ENDORSEMENT IN BILITERACY, AS DESCRIBED IN SECTION 22-7-1009.5; OR
14 GRADUATING WITH A SEAL OF CLIMATE LITERACY DIPLOMA
15 ENDORSEMENT, AS DESCRIBED IN SECTION 22-7-1009.7.

17 AND".
- 18 Page 39, line 14, strike "TECHNICAL ADVISORY PANEL" and substitute
19 "ACCOUNTABILITY WORK GROUP DESCRIBED IN SECTION 22-11-202 (3)".
- 20 Page 40, line 26, after "ASSESSMENTS." add "AS ONE PORTION OF THE
21 STUDY, THE DEPARTMENT SHALL CONSIDER THE POSSIBILITY OF INCLUDING
22 STUDENTS WITH DISABILITIES WHO ARE WORKING TOWARD EXTENDED
23 EVIDENCE OUTCOMES AND WHO RECEIVE A CERTIFICATION OF COMPLETION
24 IN THE GRADUATION STUDENT COUNT DESCRIBED IN SECTION 22-11-204
25 (4.5).".

4 THE SPECIFIC DATA ELEMENTS AND VISUAL REPORTING FORMAT FOR THE
5 STATEWIDE EDUCATION ACCOUNTABILITY DASHBOARD. THE DEPARTMENT
6 SHALL SUMMARIZE THE STAKEHOLDER INPUT, THE ESTIMATED COST FOR
7 INCORPORATING DATA ELEMENTS, AND REPORTING FORMATS WITH THE
8 STATE BOARD INTO A REPORT. THE DEPARTMENT SHALL SUBMIT THE
9 REPORT TO THE EDUCATION COMMITTEES OF THE HOUSE OF
10 REPRESENTATIVES AND THE SENATE, OR THEIR SUCCESSOR COMMITTEES,
11 AND THE JOINT BUDGET COMMITTEE. SUBJECT TO AVAILABLE
12 APPROPRIATIONS, THE DEPARTMENT SHALL CREATE A STATEWIDE
13 EDUCATION ACCOUNTABILITY DASHBOARD. ON THE".
