HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

HB18-1224 be amended as follows:

1 Amend proposed committee amendment, (HB1224\_L.005), page 1, line  
2 14, strike "**determinations.**" and substitute "**determinations - repeal.**".

3 Page 3, before line 26 insert:

4 "(VIII) BY JANUARY 1, 2022, THE OFFICE OF ADMINISTRATIVE  
5 COURTS AND THE DIVISION OF PROFESSIONS AND OCCUPATIONS IN THE  
6 DEPARTMENT OF REGULATORY AGENCIES SHALL ISSUE A JOINT REPORT TO  
7 THE JUDICIARY COMMITTEE AND THE STATE, VETERANS, AND MILITARY  
8 AFFAIRS COMMITTEE OF THE HOUSE OF REPRESENTATIVES AND THE  
9 JUDICIARY COMMITTEE AND THE STATE, VETERANS, AND MILITARY  
10 AFFAIRS COMMITTEE OF THE SENATE OR THEIR SUCCESSOR COMMITTEES.  
11 THIS SUBSECTION (4)(b)(VIII) IS REPEALED, EFFECTIVE JULY 1, 2022. THE  
12 REPORT MUST CONTAIN THE FOLLOWING:

13 (A) THE NUMBER OF HEARINGS AFFECTING LICENSES HELD  
14 BETWEEN JULY 1, 2016, AND JULY 1, 2018;

15 (B) THE NUMBER OF HEARINGS AFFECTING LICENSES HELD  
16 BETWEEN JULY 1, 2019, AND JULY 1, 2021;

17 (C) THE NUMBER OF MEDIATIONS HELD BETWEEN JULY 1, 2016,  
18 AND JULY 1, 2018;

19 (D) THE NUMBER OF MEDIATIONS HELD BETWEEN JULY 1, 2019,  
20 AND JULY 1, 2021;

21 (E) THE NUMBER OF PROCEEDINGS IN WHICH THE LICENSEE AND  
22 AGENCY AGREED TO SETTLE THE PROCEEDINGS BETWEEN JULY 1, 2016,  
23 AND JULY 1, 2018; AND

24 (F) THE NUMBER OF PROCEEDINGS IN WHICH THE LICENSEE AND  
25 AGENCY AGREED TO SETTLE THE PROCEEDINGS BETWEEN JULY 1, 2019,  
26 AND JULY 1, 2021."
