HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.

HB16-1272 be amended as follows:

- 1 Amend proposed committee amendment (HB1272_L.001), page 1, line
- 2 4, strike "LOCATED." and substitute "LOCATED AND TO THE BOARD OF
- 3 DIRECTORS OF ANY AFFECTED SPECIAL DISTRICT.".

- 4 Page 1, line 6, after "(2)" insert "(a)".

- 5 Page 1, line 7, after "SECTION," insert "EITHER".

- 6 Page 1, line 8, after "COMMISSIONERS" insert "OR THE BOARD OF
- 7 DIRECTORS OF ANY AFFECTED SPECIAL DISTRICT".

- 8 Page 1, strike line 10 and substitute:
 - 9 "Page 3, strike lines 1 through 10 and substitute "THE COUNTY THAT
 - 10 WOULD RESULT FROM THE DISCONNECTION. IF SUCH MEETING IS
 - 11 REQUESTED, THE OWNER AND THE GOVERNING BODY OR ITS APPOINTEE
 - 12 SHALL MEET WITH EITHER THE BOARD OF COUNTY COMMISSIONERS, OR ITS
 - 13 APPOINTEE, OR THE BOARD OF ANY AFFECTED SPECIAL DISTRICT, OR ITS
 - 14 APPOINTEE, NOT MORE THAN THIRTY DAYS AFTER THE MEETING WAS
 - 15 REQUESTED. FAILURE BY THE BOARD OF COUNTY COMMISSIONERS TO
 - 16 REQUEST A MEETING CONSTITUTES AN ACKNOWLEDGMENT BY THE BOARD
 - 17 THAT THE DISCONNECTION WILL NOT ADVERSELY AFFECT THE COUNTY OR
 - 18 AN AFFECTED SPECIAL DISTRICT.
 - 19 (b) AS USED IN PARAGRAPH (a) OF THIS SUBSECTION (2),
 - 20 "AFFECTED SPECIAL DISTRICT" MEANS ANY SPECIAL DISTRICT THAT BY ITS
 - 21 SERVICE PLAN OR PURSUANT TO AN INTERGOVERNMENTAL AGREEMENT IS
 - 22 OR WILL BE EXPECTED TO PROVIDE SERVICE TO THE TRACT OF LAND THAT
 - 23 IS THE SUBJECT OF THE DISCONNECTION APPLICATION. FOR PURPOSES OF
 - 24 PARAGRAPH (a) OF THIS SUBSECTION (2), "NEGATIVE IMPACT" INCLUDES
 - 25 ANY CHANGE IN THE LEVEL OR EXTENT OF SERVICES BEING PROVIDED TO
 - 26 THE TRACT OF LAND BY ANY SPECIAL DISTRICT.".
