SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB16-098 be amended as follows:

1 Amend printed bill, page 21, after line 1 insert:

2 "SECTION 25. In Colorado Revised Statutes, 24-33.5-1226,
3 amend (1) (a) as follows:

4 24-33.5-1226. **Wildfire emergency response fund - creation -**
5 **gifts, grants, and donations authorized.** (1) (a) There is hereby created
6 in the state treasury the wildfire emergency response fund, which fund
7 shall be administered by the division. The division is authorized to seek
8 and accept gifts, grants, reimbursements, or donations from private or
9 public sources for the purposes of this section. The fund consists of all
10 moneys that may be appropriated thereto by the general assembly, any
11 moneys transferred to the fund by the state treasurer pursuant to section
12 24-33.5-706 (4.5) or transferred pursuant to section 10-3-209 (4), C.R.S.,
13 and all private and public funds received through gifts, grants,
14 reimbursements, or donations that are transmitted to the state treasurer
15 and credited to the fund. EACH FISCAL YEAR, THE GENERAL ASSEMBLY
16 SHALL APPROPRIATE TO THE FUND THE SAVINGS GENERATED BY SENATE
17 BILL 16-098, ENACTED IN 2016. THE APPROPRIATION SHALL BE MADE
18 AFTER CONSIDERATION OF THE DIVISION OF CRIMINAL JUSTICE'S ANNUAL
19 REPORT REQUIRED PURSUANT TO SECTION 24-33.5-503 (1) (bb). All
20 interest earned from the investment of moneys in the fund shall be
21 credited to the fund. The moneys in the fund are hereby continuously
22 appropriated for the purposes indicated in this section. Any moneys not
23 expended at the end of the fiscal year remain in the fund and do not
24 transfer or revert to the general fund.

25 SECTION 26. In Colorado Revised Statutes, 24-33.5-503, add
26 (1) (bb) as follows:

27 24-33.5-503. **Duties of division.** (1) The division has the
28 following duties:

29 (bb) TO ANALYZE THE AMOUNT OF FISCAL SAVINGS THAT SENATE
30 BILL 16-098, ENACTED IN 2016, HAS GENERATED OVER THE PREVIOUS
31 FISCAL YEAR. BEGINNING JANUARY 15, 2017, THE DIVISION SHALL REPORT
32 THE ANALYSIS ANNUALLY TO THE JOINT BUDGET COMMITTEE."
