HOUSE COMMITTEE OF REFERENCE AMENDMENT

~~Committee on Education~~HB16-1121 be amended as follows:

1 Amend printed bill, page 2, lines 14 and 15, strike "amend (1)
2 introductory portion; and".

3 Page 2, strike lines 16 through 21 and substitute:

4 "22-9-106. Local boards of education - duties - performance
5 evaluation system - compliance - rules. (1.5) (a.5) (I) A LOCAL BOARD
6 OR BOARD OF COOPERATIVE SERVICES".

7 Page 3, strike lines 1 through 27.

8 Page 4, line 1, after "PERSONNEL" insert "PERFORMANCE".

9 Page 4, line 3, before "FROM" insert "IN ITS EMPLOY" and after "SUCH" add
10 "PERFORMANCE".

11 Page 4, line 6, strike "EXEMPTION, THE" and substitute "EXEMPTION TO
12 NATIONAL BOARD CERTIFIED TEACHERS, AN EXEMPTED".

13 Page 4, line 7, after "RECENT" insert "PERFORMANCE".

14 Page 4, line 8, strike "THE" and substitute "AN EXEMPTED NATIONAL
15 BOARD CERTIFIED".

16 Page 4, line 9, strike the second "THE" and substitute "HIS OR HER".

17 Page 4, line 10, strike the first "A" and substitute "SUCH".

18 Page 4, after line 13 insert:

19 "(II) IF A LOCAL BOARD OR BOARD OF COOPERATIVE SERVICES
20 DECIDES NOT TO GRANT THE EXEMPTION FOR NATIONAL BOARD CERTIFIED
21 TEACHERS AS PROVIDED FOR IN SUBPARAGRAPH (I) OF THIS PARAGRAPH
22 (a.5), IT IS NOT REQUIRED TO PROVIDE SUCH AN EXEMPTION TO A
23 NATIONAL BOARD CERTIFIED TEACHER WHO IS HIRED INTO ITS EMPLOY
24 FROM A SCHOOL DISTRICT THAT DOES PROVIDE SUCH AN EXEMPTION.

25 (III) IF A LOCAL BOARD OR BOARD OF COOPERATIVE SERVICES
26 DOES PROVIDE AN EXEMPTION FOR NATIONAL BOARD CERTIFIED TEACHERS
27 AS PROVIDED FOR IN SUBPARAGRAPH (I) OF THIS PARAGRAPH (a.5), IT



1 SHALL DEVELOP POLICIES RELATED TO SITUATIONS WHEN A NATIONAL
2 BOARD-CERTIFIED TEACHER IS HIRED INTO ITS EMPLOY FROM A SCHOOL
3 DISTRICT THAT ALSO ALLOWS SUCH AN EXEMPTION."
