HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.HB16-1155 be amended as follows:

- 1 Amend printed bill, page 2, after line 1 insert:
- 2 "SECTION 1. In Colorado Revised Statutes, 42-20-302, amend
3 (1) (b) as follows:
4 **42-20-302. Application for route designation - procedure -
5 approval.** (1) Petitions for new route designations or for a change in an
6 existing route designation may be submitted to the patrol no more than
7 once a year:
8 (b) By a town, city, or city and county, with respect to any public
9 road located within such town, city, or city and county, INCLUDING ANY
10 PORTION OF A COUNTY PRIMARY ROAD DESIGNATED PURSUANT TO SECTION
11 43-2-110 (1.5), C.R.S., THAT IS SUBSEQUENTLY ANNEXED BY A TOWN OR
12 CITY, upon approval of the petition by the governing body of such town,
13 city, or city and county;".
- 14 Renumber succeeding sections accordingly.
- 15 Page 2, line 5, after "COUNTY" insert "WITH A POPULATION OF TWO
16 HUNDRED FIFTY THOUSAND OR MORE".
- 17 Page 2, line 7, strike "HIGHWAY THAT IS LOCATED BOTH" and substitute
18 "HIGHWAY, THE CONSTRUCTION OF WHICH COMMENCES IN 2016, THAT IS
19 LOCATED".
- 20 Page 2, strike lines 8 through 12 and substitute "AREA OF THE COUNTY
21 AND THAT INTERSECTS WITH AN INTERSTATE HIGHWAY OR A UNITED
22 STATES NUMBERED HIGHWAY. IF A CITY OR AN INCORPORATED TOWN
23 SUBSEQUENTLY ANNEXES ANY PORTION OF A HIGHWAY THAT HAS BEEN
24 DESIGNATED AS A PRIMARY ROAD, THE RESPECTIVE JURISDICTION,
25 CONTROL, AND DUTY OF THE COUNTY AND OF THE CITY OR INCORPORATED
26 TOWN WITH RESPECT TO THE HIGHWAY IS AS FOLLOWS:".
- 27 Page 2, line 18, strike "HIGHWAY." and substitute "HIGHWAY AND TO
28 ESTABLISH WEIGHT RESTRICTIONS FOR VEHICLES TRAVELING ON THE
29 HIGHWAY AS AUTHORIZED BY SECTION 42-4-106 (1), (2), AND (3), C.R.S.".
- 30 Page 3, line 4, after "ALL" insert "OF ITS".



1 Page 3, line 5, strike "IN" and substitute "UNDER".

2 Page 3, line 7, strike "IN" and substitute "UNDER".

3 Page 5, after line 1 insert:

4 "(m) THE COUNTY MAY ENTER INTO AN INTERGOVERNMENTAL
5 AGREEMENT WITH A CITY OR INCORPORATED TOWN LOCATED WITHIN THE
6 COUNTY TO ADD TO THE HIGHWAY SPECIFIED ROADS OR STREETS ANNEXED
7 BY THE CITY OR INCORPORATED TOWN BEFORE THE DESIGNATION OF THE
8 HIGHWAY AS A PRIMARY ROAD. SUCH AN AGREEMENT MUST DEFINE THE
9 RESPECTIVE JURISDICTION, CONTROL, AND DUTY OF THE COUNTY AND THE
10 CITY OR INCORPORATED TOWN WITH RESPECT TO THE HIGHWAY AND MAY
11 MODIFY THE DIVISION OF SUCH JURISDICTION, CONTROL, AND DUTY FROM
12 THE DIVISION SPECIFIED IN PARAGRAPHS (a) TO (l) OF THIS SUBSECTION
13 (1.5).".

14 Page 1, strike line 103 and substitute "IN THE".
