Summary

This memorandum responds to your request for additional information regarding the participation of executive departments and offices in membership organizations. This memorandum provides additional information to a memorandum dated May 28, 2015. Specifically, you wanted to know what membership organizations each executive department and office belongs to and the annual expenditures for each membership. In FY 2014-15, 22 executive departments and agencies participated in approximately 597 organizations with a total payment cost of about \$2.8 million. The Department of Natural Resources participated in the most organizations at 85, with an estimated total payment cost of \$595,520.

Membership Organizations Table

Table 1 provides a list of each membership organization, the payments due by the executive departments, and the funding source for each expenditure for FY 2014-15. The information was provided by the Office of the State Controller in the Department of Personnel and Administration. The list provided included all expenses by agency. Staff did their best to identify membership organizations and associations to the extent possible using the available information. In addition, the Department of Transportation did not report memberships or allocation of funding and is therefore not included in this information. Where only an acronym is listed, no further information about the organization is available at this time.
