HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.HB16-1259 be amended as follows:

- 1 Amend printed bill, page 4, strike lines 2 through 5 and substitute:
 2 "(8) ~~Each junior A LOCAL college district which~~ THAT has a
 3 five-member board of trustees may increase the board membership to
 4 seven members at any time by the appointment of two new members. A
 5 LOCAL COLLEGE DISTRICT THAT HAS A SEVEN-MEMBER BOARD OF
 6 TRUSTEES MAY INCREASE THE BOARD MEMBERS TO NINE OR ELEVEN
 7 MEMBERS BY THE APPOINTMENT OF NEW MEMBERS IF ONE OR MORE
 8 ADDITIONAL SCHOOL DISTRICTS IS ANNEXED INTO THE LOCAL COLLEGE
 9 DISTRICT AS PROVIDED IN SECTION 23-71-128. Each person appointed".
- 10 Page 5, line 26, strike "TRUSTEES," and substitute "TRUSTEES OF
 11 COLORADO MOUNTAIN COLLEGE,".
- 12 Page 6, line 8, strike "THE BOARD" and substitute "AFTER THE BOARD
 13 RECEIVES NOTICE OF THE PROPOSED ACTION, THE BOARD SECRETARY".
- 14 Page 6, line 9, strike "PUBLIC," and substitute "PUBLIC BY POSTING NOTICE
 15 OF THE PROPOSED ACTION IN THE DESIGNATED PUBLIC PLACE FOR POSTING
 16 NOTICE OF MEETINGS DESCRIBED IN SECTION 24-6-402 (2) (c), C.R.S.,".
- 17 Page 6, line 12, strike "BOARD" and substitute "BOARD,".
- 18 Page 6, strike line 13 and substitute "NOTICE, DELIVERS A WRITTEN VOTE
 19 IN FAVOR OF TAKING THE ACTION.".
- 20 Page 6, line 22, after "BOARD" insert "OF TRUSTEES OF COLORADO
 21 MOUNTAIN COLLEGE".
- 22 Page 7, after line 25 insert:
 23 "(g) IN ADDITION TO THE LIST DESCRIBED IN SECTION 24-6-402 (7),
 24 C.R.S., THE BOARD SECRETARY SHALL MAINTAIN A LIST OF PERSONS WHO
 25 ASK FOR NOTICE OF A PROPOSED ACTION TO BE TAKEN PURSUANT TO THIS
 26 SUBSECTION (2). THE BOARD SECRETARY SHALL NOTIFY EACH PERSON ON
 27 THE LIST OF A PROPOSED ACTION AND SHALL SPECIFY IN THE NOTICE THAT
 28 A MEMBER OF THE PUBLIC MAY REQUEST THAT THE BOARD DISCUSS THE
 29 PROPOSED ACTION IN A REGULAR OR SPECIAL BOARD MEETING.".
