HB16-1300 be amended as follows:

1 Amend printed bill, page 3, after line 11 insert:

2 "SECTION 2. In Colorado Revised Statutes, amend 1-7.5-104
3 as follows:

4 **1-7.5-104. Mail ballot elections - applicability - ability of an**
5 **elector to opt not to receive mail ballots automatically - rules.** (1) For
6 all general, primary, odd-year, coordinated, recall, and congressional
7 vacancy elections conducted on or after July 1, 2013, and for any election
8 in which the governing board of a political subdivision other than a
9 county determines that an election shall be by mail ballot, the county clerk
10 and recorder or designated election official for the political subdivision,
11 as applicable, shall conduct the election by mail ballot under the
12 supervision of, and subject to rules promulgated in accordance with
13 article 4 of title 24, C.R.S., by the secretary of state.

14 (2) AN ELECTOR MAY, IN ACCORDANCE WITH RULES ADOPTED BY
15 THE SECRETARY OF STATE PURSUANT TO ARTICLE 4 OF TITLE 24, C.R.S.,
16 OPT NOT TO AUTOMATICALLY RECEIVE MAIL BALLOTS BY COMPLETING AN
17 ELECTRONIC FORM ON THE ONLINE VOTER REGISTRATION SYSTEM CREATED
18 IN ACCORDANCE WITH SECTION 1-2-202.5. SUCH OPTION MAY BE
19 SELECTED FOR ANY SINGLE ELECTION OR TO ALL ELECTIONS CONDUCTED
20 UNDER THIS CODE. AN ELECTOR SO OPTING MAY RESUME AUTOMATIC
21 RECEIPT OF MAIL BALLOTS IN ACCORDANCE WITH THE PROCESSES SET
22 FORTH BY RULE OF THE SECRETARY OF STATE."

23 Renumber succeeding sections accordingly.

24 Page 3, line 13, after "**add**" insert "(3) (a) (III) and".

25 Page 3, strike line 17 and substitute "**repeal.**
26 (3) (a) (III) NOTWITHSTANDING SUBPARAGRAPH (I) OF THIS PARAGRAPH
27 (a), MAIL BALLOTS SHALL NOT BE SENT TO ELECTORS WHO HAVE TIMELY
28 OPTED NOT TO RECEIVE MAIL BALLOTS PURSUANT TO SECTION 1-7.5-104
29 (2).

30 (4) (b) (II) (A) ~~If an eligible elector returns the ballot by mail,~~
