Committee on Finance.HB17-1370 be amended as follows:

- 3 FOR A LICENSE".
- 4 Page 9, line 9, strike "APRIL 1," and substitute "APRIL 30,".
- 5 Page 9, line 27, strike "LICENSED" and substitute "THAT APPLIED FOR A
- 6 LICENSE".
- 7 Page 10, line 1, strike "1," and substitute "30,".
- 8 Page 11, strike line 8 and substitute "(1)(b)(IV)(B), and (4)(a);".
- 9 Page 11, line 9, strike "(4)(b)(IV)(D);", and after "add" insert "(4)(b)(V)
- 10 and".
- 11 Page 11, line 19, strike "at least" and substitute "at least".
- 12 Page 12, strike lines 14 through 27 and substitute:
13 "(V) FOR A PERSON THAT SUBMITTED AN APPLICATION FOR A NEW
14 LIQUOR-LICENSED DRUGSTORE LICENSE ON OR BEFORE OCTOBER 1, 2016,
15 ADDITIONAL LIQUOR-LICENSED DRUGSTORE LICENSES AS FOLLOWS, BUT
16 ONLY IF OBTAINED IN ACCORDANCE WITH SUBSECTION (1)(b) OF THIS
17 SECTION:
18 (A) ON OR AFTER JULY 1, 2017, AND BEFORE JANUARY 1, 2022,
19 FOUR ADDITIONAL LIQUOR-LICENSED DRUGSTORE LICENSES, FOR A
20 MAXIMUM OF FIVE TOTAL LIQUOR-LICENSED DRUGSTORE LICENSES;
21 (B) ON OR AFTER JANUARY 1, 2022, AND BEFORE JANUARY 1,
22 2027, UP TO SEVEN ADDITIONAL LIQUOR-LICENSED DRUGSTORE LICENSES,
23 FOR A MAXIMUM OF EIGHT TOTAL LIQUOR-LICENSED DRUGSTORE
24 LICENSES;
25 (C) ON OR AFTER JANUARY 1, 2027, AND BEFORE JANUARY 1,
26 2032, UP TO TWELVE ADDITIONAL LIQUOR-LICENSED DRUGSTORE
27 LICENSES, FOR A MAXIMUM OF THIRTEEN TOTAL LIQUOR-LICENSED
28 DRUGSTORE LICENSES; AND
29 (D) ON OR AFTER JANUARY 1, 2032, AND BEFORE JANUARY 1,

1 2037, UP TO NINETEEN ADDITIONAL LIQUOR-LICENSED DRUGSTORE
2 LICENSES, FOR A MAXIMUM OF TWENTY TOTAL LIQUOR-LICENSED
3 DRUGSTORE LICENSES."

5 Page 13, line 11, strike "(4)(b)(IV)." and substitute "(4)(b)(V).".
