## SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.SB16-111 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and  
2 substitute:

3 "SECTION 1. In Colorado Revised Statutes, add 24-33.5-115 as  
4 follows:

5 **24-33.5-115. Peace officer authority Colorado mounted**  
6 **rangers study task force - repeal.** (1) THERE IS CREATED A PEACE  
7 OFFICER AUTHORITY COLORADO MOUNTED RANGERS STUDY TASK FORCE,  
8 REFERRED TO IN THIS SECTION AS THE "TASK FORCE", CONVENED TO STUDY  
9 AND MAKE RECOMMENDATIONS REGARDING PEACE OFFICER  
10 CERTIFICATION AND AUTHORITY FOR THE COLORADO MOUNTED RANGERS.  
11 THE TASK FORCE CONSISTS OF:

12 (a) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF PUBLIC  
13 SAFETY OR HIS OR HER DESIGNEE, WHO SHALL SERVE AS THE CHAIR OF THE  
14 TASK FORCE;

15 (b) THE ATTORNEY GENERAL OR HIS OR HER DESIGNEE;

16 (c) A REPRESENTATIVE OF THE CHIEFS OF POLICE APPOINTED BY  
17 THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF PUBLIC SAFETY;

18 (d) A COUNTY SHERIFF APPOINTED BY THE EXECUTIVE DIRECTOR  
19 OF THE DEPARTMENT OF PUBLIC SAFETY;

20 (e) THE CHIEF OF THE COLORADO STATE PATROL OR HIS OR HER  
21 DESIGNEE;

22 (f) THE DIRECTOR OF THE COLORADO BUREAU OF INVESTIGATION  
23 OR HIS OR HER DESIGNEE;

24 (g) THE DIRECTOR OF THE DIVISION OF HOMELAND SECURITY AND  
25 EMERGENCY MANAGEMENT OR HIS OR HER DESIGNEE; AND

26 (h) THE COLONEL OF THE COLORADO MOUNTED RANGERS.

27 (2) THE CHAIR OF THE TASK FORCE SHALL CONVENE THE FIRST  
28 MEETING OF THE TASK FORCE BY JUNE 1, 2016. THE TASK FORCE SHALL  
29 SCHEDULE A SUFFICIENT NUMBER OF MEETINGS IN ORDER TO COMPLETE  
30 AND SUBMIT ITS RECOMMENDATIONS PURSUANT TO SUBSECTION (4) OF  
31 THIS SECTION PRIOR TO JULY 1, 2017.

32 (3) THE TASK FORCE SHALL STUDY AND MAKE RECOMMENDATIONS  
33 REGARDING WHETHER IT IS APPROPRIATE FOR THE COLORADO MOUNTED  
34 RANGERS TO RECEIVE P.O.S.T. PEACE OFFICER CERTIFICATION, AND IF SO:

35 (a) THE APPROPRIATE LEVEL OF PEACE OFFICER CERTIFICATION FOR  
36 THE COLORADO MOUNTED RANGERS, INCLUDING THE APPROPRIATE  
37 AMOUNT OF TRAINING AND SUPERVISION;



1           (b) THE APPROPRIATE AGENCY TO HOUSE THE COLORADO  
2 MOUNTED RANGERS;  
3           (c) THE APPROPRIATE LEVEL OF PEACE OFFICER AUTHORITY OF THE  
4 COLORADO MOUNTED RANGERS;  
5           (d) THE STATUS OF A COLORADO MOUNTED RANGER WHEN THE  
6 RANGER IS NOT ON DUTY; AND  
7           (e) ANY OTHER RELEVANT MATTERS.  
8           (4) THE TASK FORCE SHALL PROVIDE RECOMMENDATIONS TO THE  
9 JUDICIARY COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND SENATE,  
10 OR ANY SUCCESSOR COMMITTEES, REGARDING APPLICATION FOR PEACE  
11 OFFICER STATUS PURSUANT TO SECTION 16-2.5-201, C.R.S.  
12           (5) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2017.  
13           **SECTION 2. Safety clause.** The general assembly hereby finds,  
14 determines, and declares that this act is necessary for the immediate  
15 preservation of the public peace, health, and safety."
