SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.SB16-180 be amended as follows:

1 Amend printed bill, page 3, line 22, after "C.R.S.," insert "OR PURSUANT
2 TO EITHER OF THESE SECTIONS AS IT EXISTED PRIOR TO ITS REPEAL AND
3 REENACTMENT, WITH AMENDMENTS, BY HOUSE BILL 96-1005,".

4 Page 5, strike lines 3 through 8 and substitute:

5 "(3) THE DEPARTMENT MAY MAKE RESTORATIVE JUSTICE
6 PRACTICES, AS DEFINED IN SECTION 18-1-901 (3) (o.5), C.R.S., AVAILABLE
7 TO ANY VICTIM OF ANY OFFENDER WHO PETITIONS FOR PLACEMENT IN THE
8 SPECIALIZED PROGRAM, AS MAY BE APPROPRIATE, BUT ONLY IF REQUESTED
9 BY THE VICTIM AND THE VICTIM HAS REGISTERED WITH THE DEPARTMENT
10 OF CORRECTIONS REQUESTING NOTICE OF VICTIMS' RIGHTS PURSUANT TO
11 THE PROVISIONS OF PART 3 OF ARTICLE 4.1 OF TITLE 24, C.R.S.".

12 Page 5, line 16, strike "SECTION" and substitute "SECTIONS".

13 Page 5, strike line 17 and substitute "24-4.1-302.5 (1) (q) AND 24-4.1-303
14 (14), C.R.S.".

15 Page 5, line 24, strike "TWO" and substitute "THREE".

16 Page 6, strike line 13 and substitute "IMPLEMENT THE SPECIALIZED
17 PROGRAM WITHIN OR IN CONJUNCTION WITH A".

18 Page 6, line 14, strike "SECURITY".

19 Page 6, line 17, after "SECURE" insert "OR LESS RESTRICTIVE".

20 Page 6, line 21, strike "TEENAGE".

21 Page 6, line 23, strike "THE BEST AND MOST" and substitute "BEST AND".

22 Page 6, strike line 27 and substitute:

23 "(3) THE DEPARTMENT MAY MAKE RESTORATIVE JUSTICE
24 PRACTICES, AS DEFINED IN SECTION 18-1-901 (3) (o.5), C.R.S., AVAILABLE
25 TO ANY VICTIM OF ANY OFFENDER WHO PETITIONS FOR PLACEMENT IN THE
26 SPECIALIZED PROGRAM, AS MAY BE APPROPRIATE, BUT ONLY IF REQUESTED
27 BY THE VICTIM AND THE VICTIM HAS REGISTERED WITH THE DEPARTMENT
28 OF CORRECTIONS REQUESTING NOTICE OF VICTIMS' RIGHTS PURSUANT TO
29 THE PROVISIONS OF PART 3 OF ARTICLE 4.1 OF TITLE 24, C.R.S.".

- 20 Page 11, line 11, strike "APPROPRIATE." and substitute "THE BOARD
21 CONSIDERS MAKING A RECOMMENDATION FOR EARLY PAROLE, AT WHICH
22 HEARING ANY VICTIM MUST HAVE THE OPPORTUNITY TO BE HEARD,
23 PURSUANT TO SECTION 24-4.1-302.5 (1) (j), C.R.S."

- 25 Page 11, line 21, strike line 21 and substitute "(1) (j) AND 24-4.1-303 (14),
26 C.R.S., AND TO THE DISTRICT ATTORNEY'S OFFICE THAT".
