SENATE COMMITTEE OF REFERENCE AMENDMENT

: Committee on Judiciary.SB17-294 be amended as follows:

1 Amend printed bill, page 65, after line 8, insert:

2 "SECTION 115. In Colorado Revised Statutes, 12-42.5-102,
3 **amend** (42)(b)(XII) as follows:

4 **12-42.5-102. Definitions.** (42)(b) "Wholesale distribution" does
5 not include:

6 (XII) The sale or transfer of compounded drugs compounded by
7 a retail pharmacy as defined in subsection (7) of this section and as
8 authorized by section ~~12-42.5-119 (6) (b)~~ 12-42.5-118 (6)(b);

9 **SECTION 116.** In Colorado Revised Statutes, 12-43.3-306,
10 **amend** (1) as follows:

11 **12-43.3-306. Denial of application.** (1) The state licensing
12 authority shall deny a state license if the premises on which the applicant
13 proposes to conduct its business does not meet the requirements of this
14 article or for reasons set forth in section ~~12-43.3-104 (1)(c)~~ 12-43.3-104
15 (1.3)(c) or 12-43.3-305, and the state licensing authority may deny a
16 license for good cause as defined by section ~~12-43.3-104 (1)(a) or (1)(b)~~
17 12-43.3-104 (1.3)(a) OR (1.3)(b).

18 **SECTION 117.** In Colorado Revised Statutes, 6-23-102, **amend**
19 **as added by House Bill 17-1115, (2)** as follows:

20 **6-23-102. Direct primary care - not regulated by the division**
21 **of insurance.** (2) Direct primary care providers and direct primary care
22 agreements that comply with this article ~~+~~ ARTICLE 23 shall not be
23 considered to be a health maintenance organization, insurer, insurance
24 producer, or insurance and are not subject to title 10.

25 **SECTION 118.** In Colorado Revised Statutes, 43-4-1001, **amend**
26 **as repealed and reenacted by Senate Bill 17-153 (2)(a)(II)** introductory
27 portion, as follows:

28 **43-4-1001. Southwest chief and front range passenger rail**
29 **service in Colorado - commission - membership and powers -**
30 **definitions.** (2) (a) The southwest chief and front range passenger rail
31 commission is created in the department of transportation. The
32 commission shall exercise its powers and perform its duties as if the same
33 were transferred to the department by a **type 1** transfer, as defined in
34 section 24-1-105. The commission consists of the following eleven
35 commissioners:

36 (II) One commissioner from each of the following metropolitan
37 planning organizations, as defined in section 43-1-1102 (4), and regional



1 planning commissions, as defined in section ~~43-4-1102(5)~~ 43-1-1102 (5),
2 appointed by the governing body of each organization or commission:
3 **SECTION 119.** (1) Except as otherwise provided in this section,
4 this act takes effect upon passage.
5 (2) Section 117 of this act takes effect only if House Bill 17-1115
6 becomes law, in which case this section takes effect upon the effective
7 date of House Bill 17-1115.
8 (3) Section 118 of this act takes effect only if Senate Bill 17-153
9 becomes law, in which case this section takes effect upon the effective
10 date of Senate Bill 17-153."
