SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.SB16-208 be amended as follows:

1 Amend printed bill, page 2, line 11, strike "CONVERSION." and substitute
2 "CONVERSION; EXCEPT THAT THIS SUBSECTION (11) DOES NOT APPLY IF
3 THE CONVERTED SCHOOL IS AUTHORIZED BY A SMALL RURAL SCHOOL
4 DISTRICT, AS DESCRIBED IN SECTION 22-54-108 (3) (b) (IV).".

5 Page 2, line 22, strike "CONVERSION." and substitute "CONVERSION;
6 EXCEPT THAT THIS SUBSECTION (7) DOES NOT APPLY IF THE CONVERTED
7 SCHOOL IS AUTHORIZED BY A SMALL RURAL SCHOOL DISTRICT, AS
8 DESCRIBED IN SECTION 22-54-108 (3) (b) (IV).".

9 Page 3, line 7, strike "CONVERSION." and substitute "CONVERSION; EXCEPT
10 THAT THIS SUBSECTION (4) DOES NOT APPLY IF THE CONVERTED SCHOOL
11 IS AUTHORIZED BY A SMALL RURAL SCHOOL DISTRICT, AS DESCRIBED IN
12 SECTION 22-54-108 (3) (b) (IV).".

13 Page 3, line 16, strike "22-30.5-513." and substitute "22-30.5-513;
14 EXCEPT THAT THIS PARAGRAPH (d) DOES NOT APPLY IF THE CONVERTED
15 SCHOOL IS AUTHORIZED BY A SMALL RURAL SCHOOL DISTRICT, AS
16 DESCRIBED IN SECTION 22-54-108 (3) (b) (IV).".

17 Page 3, line 24, strike "ARTICLE." and substitute "ARTICLE; EXCEPT THAT
18 THIS PARAGRAPH (a.7) DOES NOT APPLY IF THE CONVERTED SCHOOL WAS
19 AUTHORIZED BY A SMALL RURAL SCHOOL DISTRICT, AS DESCRIBED IN
20 SECTION 22-54-108 (3) (b) (IV), BEFORE THE CONVERSION.".

21 Page 4, line 9, strike "CONVERSION." and substitute "CONVERSION; EXCEPT
22 THAT THIS SUBSECTION (5.5) DOES NOT APPLY IF THE CONVERTED SCHOOL
23 WAS AUTHORIZED BY A SMALL RURAL SCHOOL DISTRICT, AS DESCRIBED IN
24 SECTION 22-54-108 (3) (b) (IV), BEFORE THE CONVERSION.".
