Committee on Finance.SB17-303 be amended as follows:

1 Amend printed bill, page 5, strike lines 11 and 12 and substitute:

2 "SECTION 2. In Colorado Revised Statutes, 24-75-219, amend
3 as added by Senate Bill 17-262 (2)(c.3); repeal (1)(c), (2)(a), and (2)(d);
4 and repeal as added by Senate Bill 17-262 (2)(c.7); as follows:

5 24-75-219. Transfers - transportation - capital construction -
6 definitions. (1) As used in this section, unless the context otherwise
7 requires:

8 (c) ~~"Funds" means the highway users tax fund and the capital~~

22 (c.7) ~~On June 30, 2020, the state treasurer shall transfer:~~

25 (H) ~~Sixty million dollars from the general fund to the capital~~

27 (d) ~~For each state fiscal year beginning on or after July 1, 2020;~~
28 ~~the general assembly may appropriate or transfer, in its sole discretion;~~
29 ~~moneys from the general fund to the highway users tax fund, the capital~~

32 Page 6, line 13, strike "FIVE" and substitute "TEN".

8 AND 43-4-206 (2)(a),".
