Fiscal Assessment of L.031 to HB25-1259

This memorandum is an assessment of the fiscal impact of the attached proposed amendment L.031 to HB25-1259. This fiscal assessment is for the impact of the bill with inclusion of this amendment only. Any other added amendment could influence the fiscal impact.

Summary of Proposed Amendment

Amendment L.031 removes the bill's changes to donor bank licensure renewal requirements.

Fiscal Impact of Amendment

Relative to the published fiscal note, Amendment L.031 eliminates the decrease in state revenue from reducing the frequency of licensure fees paid by donor backs. Existing licensing requirements would be maintained.

Bill's Revised Fiscal Impact with Amendment

With Amendment L.031, the bill would have only minimal state workload impacts that require no change in appropriation for the Department of Public Health and Environment.
