HB24-1379 be amended as follows:

- 1 Amend printed bill, page 5, line 13, strike "WATER," and substitute
- 2 "WATER AND WILDLIFE HABITATS,".
- 3 Page 7, after line 14 insert:
- 4 "(a) "AQUATIC ECOSYSTEM" MEANS STATE WATERS THAT SERVE
- 5 AS HABITAT FOR INTERRELATED AND INTERACTING COMMUNITIES AND
- 6 POPULATIONS OF PLANTS AND ANIMALS.".
- 7 Reletter succeeding paragraphs accordingly.
- 8 Page 8, line 3, strike "(3)(d)(II)" and substitute "(3)(e)(II)".
- 9 Page 9, line 5, strike "(3)(e)(II)" and substitute "(3)(f)(II)".
- 10 Page 11, line 6, strike "AND" and substitute "GEOMORPHIC, OR".
- 11 Page 11, line 9, strike "(3)(k)(III)" and substitute "(3)(l)(III)".
- 12 Page 11, strike lines 19 through 27.
- 13 Page 12, strike line 1.
- 14 Reletter succeeding paragraphs accordingly.
- 15 Page 12, line 18, after "**fill**" insert "**discharge**".
- 16 Page 13, strike lines 8 through 14 and substitute:
- 17 "(D) DETAILS CONCERNING THE DIVISION'S CONSULTATION WITH
- 18 FEDERAL, STATE, LOCAL, AND TRIBAL ENTITIES, ESPECIALLY THOSE
- 19 ENTITIES WITH SPECIAL EXPERTISE WITH RESPECT TO ANY
- 20 ENVIRONMENTAL-, NATURAL RESOURCE-, OR AGRICULTURE-RELATED
- 21 ISSUE; AND
- 22 (II) MAY INCLUDE:
- 23 (A) FURTHER CLARIFICATION OF THE TERMINOLOGY USED TO".
- 24 Page 13, line 18, strike "(C)" and substitute "(B)".
- 25 Page 13, line 22, strike "(4)(a)(II)(C)," and substitute "(4)(a)(II)(B)".

- 1 Page 13, strike lines 24 and 25 and substitute "SHORT DURATION AS THE
2 DIRECT RESULT OF, PRECIPITATION EVENTS AND THAT HAS A CHANNEL
3 BOTTOM THAT IS ALWAYS ABOVE".
- 4 Page 14, strike lines 15 through 22 and substitute "THE AQUATIC
5 ECOSYSTEM SO LONG AS THE ALTERNATIVE DOES NOT HAVE OTHER
6 SIGNIFICANT ADVERSE ENVIRONMENTAL CONSEQUENCES. THE RULES MUST
7 ALSO INCLUDE CRITERIA FOR THE DIVISION TO USE TO IMPLEMENT THE
8 PROHIBITION, INCLUDING CONSIDERATION OF THE FEASIBILITY OF
9 SECURING NECESSARY WATER RIGHTS IN".

- 11 "(C) ADDRESS THE DIRECT, INDIRECT, AND CUMULATIVE IMPACTS
12 OF THE".
- 13 Page 16, line 10, after "AND" insert "THEN".
- 14 Page 16, lines 17 and 18, strike "THE AQUATIC ENVIRONMENT." and
15 substitute "AQUATIC ECOSYSTEMS".
- 16 Page 16, line 24, after "RESTORATION" insert "AND ENHANCEMENT".
- 17 Page 16, strike lines 26 and 27.
- 18 Page 17, strike lines 1 through 5.
- 19 Renumber succeeding subparagraphs accordingly.
- 20 Page 17, line 10, strike "(5)(b)(III):" and substitute "(5)(b)(II):".
- 21 Page 17, line 22, strike "(5)(b)(III)(B)," and substitute "(5)(b)(II)(B),".
- 22 Page 18, line 23, strike "ENGINEERS AND ISSUE" and substitute
23 "ENGINEERS, INCLUDING".
- 24 Page 19, strike lines 18 and 19 and substitute "DIVISION'S OBJECTIONS
25 WITH SPECIFICITY, IS SUBJECT TO DIRECT JUDICIAL REVIEW UNDER SECTION
26 25-8-404, AND IS NOT SUBJECT TO ADMINISTRATIVE RECONSIDERATION
27 UNDER SECTION 25-8-403".
- 28 Page 19, after line 26 insert:

1 "(f) **Administrative guidance.** THE DIVISION MAY ESTABLISH
2 GUIDANCE TO ASSIST IN ADMINISTERING THE DREDGE AND FILL DISCHARGE
3 AUTHORIZATION PROGRAM. ADDITIONALLY, THE DIVISION MAY RELY UPON
4 RELEVANT GUIDANCE FROM THE FEDERAL ENVIRONMENTAL PROTECTION
5 AGENCY AND THE UNITED STATES ARMY CORPS OF ENGINEERS, INCLUDING
6 TECHNICAL GUIDANCE AND ENVIRONMENTAL ANALYSES UNDER THE
7 FEDERAL "NATIONAL ENVIRONMENTAL POLICY ACT OF 1969", 42 U.S.C.
8 SEC. 4231 ET SEQ., AS AMENDED, IN ADMINISTERING THE PROGRAM, TO THE
9 EXTENT SUCH GUIDANCE IS CONSISTENT WITH THIS SECTION AND THE
10 COMMISSION'S RULES.

11 (g) **Western slope staff.** THE DIVISION MAY, TO THE EXTENT
12 RESOURCES ALLOW, ESTABLISH ONE OR MORE STAFF POSITIONS IN THE
13 WESTERN SLOPE REGION OF THE STATE TO ASSIST WITH DREDGE AND FILL
14 PROGRAM ADMINISTRATION IN THAT GEOGRAPHIC AREA."

15 Page 21, line 7, strike "**material**".

16 Page 21, strike lines 19 through 27 and substitute:

17 "(I) ACTIVITIES IN RECEIPT OF AN ACTIVE SECTION 404 PERMIT
18 THAT WAS ISSUED PRIOR TO MAY 25, 2023;

19 (II) ACTIVITIES IN RECEIPT OF AN UNEXPIRED APPROVED
20 JURISDICTIONAL DETERMINATION ISSUED BY THE UNITED STATES ARMY
21 CORPS OF ENGINEERS PRIOR TO MAY 25, 2023, FINDING THAT THE STATE
22 WATERS INTO WHICH THE PROPOSED DISCHARGE OF DREDGED OR FILL
23 MATERIAL WILL OCCUR ARE NOT WATERS OF THE UNITED STATES;

24 (III) ACTIVITIES IN RECEIPT OF AN ACTIVE SECTION 404 PERMIT
25 THAT WAS ISSUED ON OR AFTER MAY 25, 2023, EXCEPT TO THE EXTENT
26 THAT THE PROJECT AREA OF THE SECTION 404 PERMIT INVOLVES A
27 DISCHARGE OF DREDGED OR FILL MATERIAL INTO STATE WATERS THAT
28 HAVE BEEN DETERMINED BY THE UNITED STATES ARMY CORPS OF
29 ENGINEERS TO NOT BE WATERS OF THE UNITED STATES;".

30 Page 22, strike lines 16 through 19 and substitute "STRUCTURES.

31 (VI) CONSTRUCTION OR MAINTENANCE OF FARM PONDS, STOCK
32 PONDS, AND IRRIGATION DITCHES USED ONLY FOR AGRICULTURAL
33 PURPOSES OR MAINTENANCE OF DRAINAGE DITCHES AND IRRIGATION
34 DITCHES THAT ALSO CARRY WATER FOR MUNICIPAL OR INDUSTRIAL USE.
35 AS".

36 Page 23, strike lines 18 and 19 and substitute:

37 "(C) "MAINTENANCE" PERTAINING TO AN IRRIGATION DITCH, A

1 DRAINAGE DITCH, OR A DITCH THAT CARRIES RAW WATER FOR MUNICIPAL
2 OR INDUSTRIAL USE INCLUDES A REPAIR TO AN EXISTING STRUCTURE OR".

3 Page 25, strike lines 7 through 9 and substitute "ROADSIDE DITCHES, AND
4 IRRIGATION DITCHES THAT ARE EXCAVATED ON UPLAND;

5 (II) STORM WATER CONTROL FEATURES THAT ARE CONSTRUCTED
6 TO CONVEY, TREAT, OR STORE STORM WATER AND THAT ARE CREATED IN
7 UPLAND;".

8 Renumber succeeding subparagraphs accordingly.

9 Page 25, strike lines 14 through 16 and substitute "THAT ARE USED
10 EXCLUSIVELY FOR STOCK WATERING, IRRIGATION, SETTLING BASINS, OR
11 RICE GROWING;".

12 Page 26, line 1, strike "(8)(d)(VII)," and substitute "(8)(d)(VIII),".

13 Page 26, line 7, strike "(8)(d)(VIII)," and substitute "(8)(d)(IX),".

14 Page 26, line 14, strike "(8)(d)(VIII)," and substitute "(8)(d)(IX),".
