

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

HB24-1345 be amended as follows:

1 Amend printed bill, page 2, after line 15 insert:

2 "SECTION 3. In Colorado Revised Statutes, 24-30-2102, **amend**
3 (1) and (1.5) as follows:

4 **24-30-2102. Legislative declaration.** (1) The general assembly
5 finds and declares that a person attempting to escape from actual or
6 threatened domestic violence, a sexual offense, HUMAN TRAFFICKING, or
7 stalking frequently moves to a new address in order to prevent an
8 assailant or potential assailant from finding the victim. This new address,
9 however, is only useful if an assailant or potential assailant does not
10 discover it. Additionally, people involved in the provision of reproductive
11 health care are at a heightened risk of actual or threatened violence,
12 stalking, or other social harms.

13 (1.5) Therefore, in order to help victims of domestic violence, a
14 sexual offense, HUMAN TRAFFICKING, or stalking, and to assist and protect
15 individuals involved in the provision of reproductive health care, it is the
16 intent of the general assembly to establish an address confidentiality
17 program, whereby the confidentiality of a victim's or an individual
18 involved in the provision of reproductive health care's address may be
19 maintained through, among other things, the use of a substitute address
20 for purposes of public records and confidential mail forwarding."

21 **SECTION 4.** In Colorado Revised Statutes, 24-30-2103, **amend**
22 (2); and **add** (7.5) as follows:

23 **24-30-2103. Definitions.** As used in this part 21, unless the
24 context otherwise requires:

25 (2) "Address confidentiality program" or "program" means the
26 program created under this part 21 in the department to protect the
27 confidentiality of the actual address of a relocated protected health-care
28 worker or a relocated victim of domestic violence, a sexual offense,
29 HUMAN TRAFFICKING, or stalking.

30 (7.5) "HUMAN TRAFFICKING" MEANS AN ACT DESCRIBED IN
31 SECTION 18-3-503 OR 18-3-504.

32 **SECTION 5.** In Colorado Revised Statutes, 24-30-2104, **amend**
33 (1) introductory portion and (4)(a) as follows:

34 **24-30-2104. Address confidentiality program - creation -**
35 **substitute address - uses - service by mail - application assistance**
36 **centers.** (1) There is created the address confidentiality program in the
37 department to protect the confidentiality of the actual address of a
38 relocated protected health-care worker or a relocated victim of domestic
39 violence, a sexual offense, HUMAN TRAFFICKING, or stalking and to
40 prevent the victim's assailants or potential assailants from finding the

1 victim through public records. Under the program, the executive director
2 or the executive director's designee shall:

3 (4) The executive director or the executive director's designee may
4 designate as an application assistant any person who:

5 (a) Provides counseling, referral, or other services to victims of
6 domestic violence, a sexual offense, HUMAN TRAFFICKING, or stalking, if
7 applicable;

8 **SECTION 6.** In Colorado Revised Statutes, 24-30-2105, **amend**
9 (3)(b), (3)(c) introductory portion, (3)(c)(IV), and (3)(h) as follows:

10 **24-30-2105. Filing and certification of applications -**
11 **authorization card.** (3) The application must be on a form prescribed by
12 the executive director or the executive director's designee and must
13 contain the following:

14 (b) A statement by the applicant that the applicant is a victim of
15 domestic violence, a sexual offense, HUMAN TRAFFICKING, or stalking and
16 that the applicant fears for the applicant's safety, if applicable;

17 (c) Evidence that the applicant is a victim of domestic violence,
18 a sexual offense, HUMAN TRAFFICKING, or stalking, if applicable. This
19 evidence may include any of the following:

20 (IV) Documentation from a religious, medical, or other
21 professional from whom the applicant has sought assistance in dealing
22 with the alleged domestic violence, sexual offense, HUMAN TRAFFICKING,
23 or stalking.

24 (h) The actual address that the applicant requests not to be
25 disclosed by the executive director or the executive director's designee
26 that directly relates to the increased risk of domestic violence, a sexual
27 offense, HUMAN TRAFFICKING, or stalking, or increased risk of actual or
28 threatened violence, stalking, HUMAN TRAFFICKING, or other social harms
29 due to the provision of a legally protected health-care activity, as defined
30 in section 12-30-121 (1)(d);

31 **SECTION 7.** In Colorado Revised Statutes, 24-30-2112, **amend**
32 (2) as follows:

33 **24-30-2112. Participation in the program - orders relating to**
34 **allocation of parental responsibilities or parenting time.** (2) Program
35 participation does not constitute evidence of domestic violence, a sexual
36 offense, HUMAN TRAFFICKING, or stalking and shall not be considered for
37 purposes of making an order allocating parental responsibilities or
38 parenting time; except that a court may consider practical measures to
39 keep a program participant's actual address confidential when making an
40 order allocating parental responsibilities or parenting time.

41 **SECTION 8.** In Colorado Revised Statutes, 24-30-2114, **amend**
42 (2)(c); and add (2)(a.5) and (2)(a.6) as follows:

43 **24-30-2114. Surcharge - collection and distribution - address**

1 **confidentiality program surcharge fund - creation - definitions.**
2 (2) The following crimes shall be subject to the surcharge set forth in
3 subsection (1) of this section:
4 (a.5) HUMAN TRAFFICKING FOR INVOLUNTARY SERVITUDE OR
5 HUMAN TRAFFICKING OF A MINOR FOR INVOLUNTARY SERVITUDE IN
6 VIOLATION OF SECTION 18-3-503;
7 (a.6) HUMAN TRAFFICKING FOR SEXUAL SERVITUDE OR HUMAN
8 TRAFFICKING OF A MINOR FOR SEXUAL SERVITUDE IN VIOLATION OF
9 SECTION 18-3-504;
10 (c) Criminal attempt, conspiracy, or solicitation to commit the
11 crimes set forth in ~~paragraphs (a) and (b)~~ SUBSECTIONS (2)(a), (2)(a.5),
12 (2)(a.6), AND (2)(b) of this ~~subsection (2)~~ SECTION."
13 Renumber succeeding section accordingly.
