4 **42-4-1409. Compulsory insurance - penalty - legislative intent.**

5 (4) (a) ~~Any~~ A person who violates the provisions of subsection
6 (1), (2), or (3) of this section commits a ~~class 1 misdemeanor traffic~~
7 ~~offense. The minimum fine imposed by section 42-4-1701 (3)(a)(H)(A)~~
8 ~~shall be mandatory, and the defendant shall be punished by a minimum~~
9 ~~mandatory fine of not less than five hundred dollars~~ CLASS A TRAFFIC
10 INFRACTION AND UPON CONVICTION THEREOF, NOTWITHSTANDING
11 SECTION 42-4-1701 (3)(a)(I), SHALL BE PUNISHED BY A FIVE HUNDRED
12 DOLLAR FINE; EXCEPT THAT FOR A SECOND OR SUBSEQUENT CONVICTION
