SB24-115 be amended as follows:

1 Amend reengrossed bill, page 3, strike lines 17 through 27.

2 Page 4, strikes lines 1 and 2 and substitute "(3) is under the jurisdiction

9 LICENSED PROFESSIONAL COUNSELOR CANDIDATE."

10 Page 10, line 13, strike "AND".

11 Page 10, strike lines 15 through 24 and substitute:

14 (III) ALLOWANCE OF A PERSON WHILE IN THE FINAL SEMESTER OF
15 A MASTER'S OR DOCTORAL DEGREE IN PROFESSIONAL COUNSELING FROM
16 AN ACCREDITED SCHOOL, COLLEGE, OR EQUIVALENT PROGRAM TO
17 PRACTICE IN ACCORDANCE WITH SECTION 12-245-217 (2)(g) AFTER THE
18 PERSON'S PRACTICUM AND INTERNSHIP IS COMPLETED; AND

19 (IV) THE CONTINUING PROFESSIONAL COMPETENCY
20 REQUIREMENTS SPECIFIED IN SUBSECTION (4)(c) OF THIS SECTION."

21 Page 11, strike lines 11 through 24 and substitute:

22 "(b) An addiction counselor candidate registered pursuant to this
23 subsection (3.7) is under the jurisdiction of the board. If the requirements
24 of subsections (1)(d) to (1)(g) of this section are not met within ~~four~~
25 THREE years after the date of registration as a candidate or within one year
26 if the candidate holds an equivalent credential from another state, the
27 registration of the addiction counselor candidate ~~expires and is not~~
28 ~~renewable unless the board, in its discretion, grants the candidate an~~
29 ~~extension. A person whose addiction counselor candidate registration~~
30 ~~expires is not precluded from applying for licensure or registration with~~
31 ~~any other mental health board for which the person is qualified~~ IS SUBJECT
32 TO THE RENEWAL, REINSTATEMENT, AND DELINQUENCY FEE PROVISIONS
33 SPECIFIED IN SECTION 12-20-202. PRIOR TO A SECOND OR SUBSEQUENT
34 RENEWAL OF AN ADDICTION COUNSELOR CANDIDATE REGISTRATION, THE
35 REGISTERED ADDICTION COUNSELOR CANDIDATE SHALL COMPLETE
36 CONTINUING PROFESSIONAL COMPETENCY HOURS TO MAINTAIN THE
37 REGISTERED ADDICTION COUNSELOR'S REGISTRATION AS A REGISTERED
38 ADDICTION COUNSELOR CANDIDATE."

39 Page 12, strike lines 5 through 12 and substitute:

40 "(II) THE RENEWAL, REINSTATEMENT, AND DELINQUENCY FEE
41 PROVISIONS SPECIFIED IN SECTION 12-20-202; AND

1 (III) THE CONTINUING PROFESSIONAL COMPETENCY
2 REQUIREMENTS SPECIFIED IN SUBSECTION (3.7)(b) OF THIS SECTION."
