Committee on Health & Human Services.

HB24-1384 be amended as follows:

1 Amend printed bill, page 3, after line 6 insert:

2 "(b) IN DEVELOPING THE GRANT APPLICATION, THE STATE
3 DEPARTMENT AND THE BEHAVIORAL HEALTH ADMINISTRATION SHALL
4 DEMONSTRATE THAT THE DEMONSTRATION PLANNING GRANT IS IN THE
5 BEST INTEREST OF THE STATE AS ILLUSTRATED BY:

6 (I) THE REQUIREMENT TO SERVE PRIORITY POPULATIONS, AS
7 DEFINED IN SECTION 27-50-101;

8 (II) THE PROVISION OF BEHAVIORAL HEALTH SERVICES, AS DEFINED
9 IN SECTION 27-50-101;

10 (III) THE REQUIREMENT FOR A BEHAVIORAL HEALTH SAFETY NET
11 PROVIDER TO SERVE ALL POPULATIONS REGARDLESS OF AN INDIVIDUAL'S
12 CONDITION OR ABILITY TO PAY FOR SERVICES, AS DESCRIBED IN SECTION
13 27-50-301;

14 (IV) PEER SUPPORTS AND PEER COUNSELING;

15 (V) THE REQUIREMENT FOR INCORPORATING MEANINGFUL
16 PARTICIPATION FROM INDIVIDUALS WITH LIVED EXPERIENCE OF A MENTAL
17 HEALTH DISORDER OR SUBSTANCE USE DISORDER AND THE INDIVIDUAL'S
18 FAMILY MEMBERS, INCLUDING YOUTH, IN ALL ASPECTS OF THE
19 DECISION-MAKING PROCESS;

20 (VI) QUALITY AND REPORTING REQUIREMENTS;

21 (VII) THE AVAILABILITY OF CERTIFIED COMMUNITY BEHAVIORAL
22 HEALTH CLINIC CERTIFICATION FOR ANY BEHAVIORAL HEALTH ENTITY
23 THAT IS DESIGNATED BY THE BEHAVIORAL HEALTH ADMINISTRATION AS A
24 COMPREHENSIVE COMMUNITY BEHAVIORAL HEALTH PROVIDER OR
25 ESSENTIAL COMMUNITY BEHAVIORAL HEALTH PROVIDER AND WHICH
26 MEETS THE FEDERAL REQUIREMENTS;

27 (VIII) A LACK OF GEOGRAPHIC LIMITATION ON THE NUMBER OF
28 CERTIFIED COMMUNITY BEHAVIORAL HEALTH CLINICS IN A REGION;

29 (IX) ASSURANCE THAT CERTIFIED COMMUNITY BEHAVIORAL
30 HEALTH CLINIC CRISIS SERVICES ARE DELIVERED WITHIN THE PARAMETER
31 OF COLORADO'S STATEWIDE CRISIS RESPONSE SYSTEM AND THAT ANY
32 CRISIS SERVICES DELIVERED BY THE CERTIFIED COMMUNITY BEHAVIORAL
33 HEALTH CLINIC ARE ALIGNED WITH THE SERVICES PROVIDED THROUGH THE
34 STATEWIDE CRISIS RESPONSE SYSTEM; AND

35 (X) NO NEGATIVE IMPACT ON RURAL ACCESS, AS WELL AS
36 ENSURING CERTIFIED COMMUNITY BEHAVIORAL HEALTH CLINICS WILL NOT
37 SIGNIFICANTLY REDUCE THE NUMBER OF AGENCIES PROVIDING
38 COMPREHENSIVE SAFETY NET SERVICE."
