

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

SB24-047 be amended as follows:

- 1 Amend proposed committee amendment (SB47\_L.016), page 1, line 29,  
2 strike "COMMUNITY." and substitute "COMMUNITY.
- 3 (3) (a) (I) THE CHAIR OF THE LOCAL TEAM MUST BE THE COUNTY  
4 OR DISTRICT PUBLIC HEALTH DIRECTOR. IF THE COUNTY OR DISTRICT  
5 PUBLIC HEALTH DIRECTOR IS UNABLE TO PARTICIPATE, THE DIRECTOR MAY  
6 DESIGNATE A PERSON EMPLOYED BY THE COUNTY OR DISTRICT HEALTH  
7 AGENCY THAT HOUSES THE LOCAL TEAM TO SERVE AS THE CHAIR OF THE  
8 LOCAL TEAM.
- 9 (II) IF A LOCAL TEAM IS A MULTICOUNTY OR MULTIDISTRICT TEAM,  
10 THE MEMBERS OF THE TEAM MAY VOTE TO APPOINT ONE OF THE COUNTY  
11 OR DISTRICT PUBLIC HEALTH DIRECTORS TO SERVE AS CHAIR, OR APPOINT  
12 THE DIRECTOR'S DESIGNEE, OR THE COUNTY OR DISTRICT PUBLIC HEALTH  
13 DIRECTORS OR DESIGNEES MAY SERVE AS CO-CHAIRS.
- 14 (b) THE CHAIR OF THE LOCAL TEAM IS RESPONSIBLE FOR THE  
15 FOLLOWING:
- 16 (I) SOLICITING AND RECRUITING THE NECESSARY AND  
17 APPROPRIATE MEMBERS TO SERVE ON THE LOCAL TEAM PURSUANT TO  
18 SUBSECTIONS (1) AND (2) OF THIS SECTION;
- 19 (II) FACILITATING EACH LOCAL TEAM MEETING AND  
20 IMPLEMENTING THE PROTOCOLS AND PROCEDURES OF THE LOCAL TEAM;
- 21 (III) ENSURING THAT ALL MEMBERS OF THE LOCAL TEAM AND ALL  
22 GUEST OBSERVERS SIGN CONFIDENTIALITY FORMS;
- 23 (IV) REQUESTING AND COLLECTING THE INFORMATION NEEDED  
24 FOR THE LOCAL TEAM'S CASE REVIEW;
- 25 (V) FILLING VACANCIES ON THE LOCAL TEAM WHEN A MEMBER IS  
26 NO LONGER ABLE TO FULFILL THE MEMBER'S DUTIES AND OBLIGATIONS TO  
27 THE LOCAL TEAM. WHEN A MEMBER LEAVES, THE MEMBER SHOULD BE  
28 REPLACED WITH AN INDIVIDUAL FROM THE SAME OR EQUIVALENT POSITION  
29 OR DISCIPLINE; AND
- 30 (VI) SERVING AS A LIAISON FOR THE LOCAL TEAM WHEN  
31 NECESSARY.".
