HB24-1047 be amended as follows:

- 1 Amend printed bill, page 3, line 14, strike "(21.5), and (24);" and
2 substitute "and (21.5);".
- 3 Page 4, strike lines 10 through 12 and substitute:
4 "(a) ~~treatment or collection of diagnostic information of a patient~~
5 ~~at veterinary premises without being on the premises but being~~ PROVIDES
6 EITHER WRITTEN OR VERBAL INSTRUCTIONS FOR THE TASKS THAT HAVE

- 11 Page 5, strike lines 12 and 13.
- 12 Page 5, line 25, strike "(1)(r) and (1)(s)" and substitute "(1)(r), (1)(s), and
13 (1)(t)".
- 14 Page 6, line 8, strike "AUTHORIZE TREATMENT PLANS FOR,".
- 15 Page 6, strike lines 10 and 11 and substitute:
16 "(j) Any ~~person~~ INDIVIDUAL from performing ~~duties other than~~
17 ~~diagnosis, prescription, surgery, or initiating treatment~~ TASKS under the
18 ~~direction~~".
- 19 Page 6, strike lines 15 through 20 and substitute "12-315-105.5".
- 20 Page 6, line 21, strike "THE" and substitute "AT LEAST INDIRECT".
- 21 Page 6, line 23, after "PROPERTY" insert "OR UNDER THE STEWARDSHIP".
- 22 Page 7, strike lines 1 through 18 and substitute "THE INDIVIDUAL HAS
23 RECEIVED SUFFICIENT AND PROPER TRAINING;
24 (s) AN INDIVIDUAL FROM PERFORMING ACCEPTED ANIMAL
25 HUSBANDRY ON LIVESTOCK AS THOSE TERMS ARE DEFINED IN SECTION
26 35-42-103 IF THE INDIVIDUAL IS AN OWNER OF AN ANIMAL OR IS AN
27 INDIVIDUAL ACTING UNDER THE DIRECTION OF THE OWNER OF THE ANIMAL
28 PURSUANT TO SUBSECTION (1)(f)(I) OF THIS SECTION; OR
29 (t) AN INDIVIDUAL FROM PERFORMING TASKS ON LIVESTOCK

1 UNDER THE SUPERVISION OF A LICENSED VETERINARIAN AND:
2 (I) THE SUPERVISING LICENSED VETERINARIAN HAS ESTABLISHED
3 A VETERINARIAN-CLIENT-PATIENT RELATIONSHIP WITH THE LIVESTOCK
4 AND THE OWNER OF THE LIVESTOCK;
5 (II) THE INDIVIDUAL IS PERFORMING TASKS IN COMPLIANCE WITH
6 WRITTEN OR VERBAL INSTRUCTIONS OR COMMUNICATIONS DEVELOPED BY
7 THE SUPERVISING LICENSED VETERINARIAN; AND
8 (III) THE SUPERVISING LICENSED VETERINARIAN HAS DETERMINED
9 THE INDIVIDUAL PERFORMING THE TASKS HAS RECEIVED SUFFICIENT AND
10 PROPER TRAINING."

11 Page 8, strike lines 9 through 18 and substitute "TASKS IN ACCORDANCE
12 WITH THIS SECTION AND RULES ADOPTED BY THE BOARD PURSUANT TO
13 THIS SECTION.

14 (2) A LICENSED VETERINARIAN SHALL ESTABLISH A
15 VETERINARIAN-CLIENT-PATIENT RELATIONSHIP BEFORE THE
16 VETERINARIAN DELEGATES A TASK TO A VETERINARY TECHNICIAN, A
17 VETERINARY TECHNICIAN SPECIALIST, OR OTHER QUALIFIED PERSONNEL."

18 Page 8, line 27, strike "SUBSECTION (4)" and substitute "SUBSECTIONS (4),
19 (6), AND (7)".

20 Page 9, line 20, strike "SECTION." and substitute "PART 1."

21 Page 9, strike lines 24 through 26 and substitute "OR A VETERINARY
22 TECHNICIAN SPECIALIST AND THE STATED LEVEL OF SUPERVISION TO
23 PERFORM THOSE TASKS:".

24 Page 10, line 6, strike "TUBES;" and substitute "TUBES."

25 Page 10, line 11, strike "INCLUDING:" and substitute "INCLUDING, AT A
26 MINIMUM:".

27 Page 10, strike lines 17 and 18 and substitute:

28 "(II) PLACEMENT OF EPIDURAL AND INTRAOSSEOUS CATHETERS;
29 (III) SUTURING, STAPLING, OR GLUING AN EXISTING SURGICAL SKIN
30 INCISION; AND

31 (IV) TREATMENT OF MINOR MEDICAL CONDITIONS, AS DETERMINED
32 BY THE LICENSED VETERINARIAN, IF:

33 (A) THE VETERINARY TECHNICIAN OR VETERINARY TECHNICIAN
34 SPECIALIST HAS THE TRAINING AND COMPETENCY TO PERFORM THE
35 TREATMENT;

36 (B) THE TREATMENT IS PERFORMED IN CONSULTATION WITH THE
37 LICENSED VETERINARIAN OR UNDER PREVIOUSLY ESTABLISHED WRITTEN

1 PROTOCOLS; AND
2 (C) THE LICENSED VETERINARIAN IS AVAILABLE TO MANAGE THE
3 CASE IF IT IS DETERMINED THAT THE CONDITION OF THE PATIENT REQUIRES
4 CARE BEYOND THE ABILITIES OF THE VETERINARY TECHNICIAN OR
5 VETERINARY TECHNICIAN SPECIALIST.".

6 Page 11, line 15, after "CATHETERIZATION," insert "CYSTOCENTESIS,".

7 Page 11, strike lines 24 and 25 and substitute:

8 "(IX) ADMINISTRATION OF A THERAPEUTIC LASER, EXCEPT FOR
9 THE USE OF SURGICAL LASERS;
10 (X) APPLICATION OF ANIMAL REHABILITATION THERAPIES;".

11 Page 12, strike lines 11 through 18 and substitute:

12 "(XVIII) FLUID ASPIRATION FROM A BODY CAVITY OR ORGAN;
13 (XIX) MINOR WOUND MANAGEMENT;
14 (XX) PLACEMENT OF NASAL CATHETERS; AND
15 (XXI) EMERGENCY PATIENT CARE, SUCH AS:".

16 Page 13, strike lines 1 and 2 and substitute: "ANIMAL, UP TO AND
17 INCLUDING EUTHANASIA; AND".

18 Page 13, strike lines 6 through 23 and substitute:

19 "(5) (a) IN PROMULGATING RULES PURSUANT TO THIS SECTION
20 RELATED TO THE DELEGATION OF TASKS AND SUPERVISION OF VETERINARY
21 PROFESSIONALS OR OTHER PERSONNEL, THE BOARD SHALL:
22 (I) CONSULT WITH LICENSED VETERINARIANS, REGISTERED
23 VETERINARY TECHNICIANS, VETERINARY TECHNICIAN SPECIALISTS,
24 CLIENTS, AND OTHER RELEVANT STAKEHOLDERS, AS DETERMINED BY THE
25 BOARD; AND
26 (II) PERMIT A VETERINARY TECHNICIAN SPECIALIST TO PERFORM
27 ANY TASK UNDER AT LEAST INDIRECT SUPERVISION BY A LICENSED
28 VETERINARY IN ACCORDANCE WITH SUBSECTION (6) OF THIS SECTION.
29 (b) THE BOARD SHALL REVIEW AND UPDATE THE RULES
30 PROMULGATED PURSUANT TO THIS SECTION AS NECESSARY TO ACCOUNT
31 FOR DEVELOPMENTS IN THE PRACTICE OF VETERINARY MEDICINE AND
32 VETERINARY TECHNOLOGY.".

33 Page 14, line 1, strike "TRAINING AND EXPERIENCE" and substitute
34 "TRAINING, EXPERIENCE, AND COMPETENCY".

35 Page 14, line 2, strike "ARTICLE 315" and substitute "ARTICLE 315, AN

1 APPLICABLE BOARD RULE,".

2 Page 14, strike lines 4 through 8 and substitute:

3 "(7) NOTWITHSTANDING ANY PROVISION OF THIS ARTICLE 315, AN
4 APPLICABLE BOARD RULE, OR ANY OTHER STATE OR FEDERAL LAW, A
5 LICENSED VETERINARIAN MAY DELEGATE A TASK TO AN INDIVIDUAL WHO
6 IS NOT A VETERINARY TECHNICIAN OR VETERINARY TECHNICIAN
7 SPECIALIST IF THE VETERINARIAN DETERMINES THAT THE TASK IS WITHIN
8 THE INDIVIDUAL'S TRAINING AND EXPERIENCE AND THE INDIVIDUAL IS
9 UNDER THE VETERINARIAN'S DIRECT OR IMMEDIATE SUPERVISION; EXCEPT
10 THAT THE TREATMENT OF MINOR MEDICAL CONDITIONS MAY ONLY BE
11 DELEGATED TO A VETERINARY TECHNICIAN OR VETERINARY TECHNICIAN
12 SPECIALIST IN ACCORDANCE WITH SUBSECTION (4)(b)(IV) OF THIS
13 SECTION.".

14 Page 19, line 24, strike "(4)," and substitute "(4) OR (6),".

15 Amend printed bill, strike "VETERINARY MEDICINE" on: **Page 3**, lines 20,
16 23, and 26; **Page 4**, line 5; **Page 8**, lines 20 and 27; **Page 9**, lines 4, 6 and
17 7, 13 and 14, and 22; **Page 13**, lines 24 and 25; and **Page 15**, lines 10 and
18 25.

19 Page 1, line 105, strike "VETERINARY MEDICINE"
