Committee on State, Civic, Military, & Veterans Affairs.

HB24-1326 be amended as follows:

1 Amend printed bill, page 2, strike lines 2 and 3 and substitute:

2 **"SECTION 1.** In Colorado Revised Statutes, 24-21-602, **repeal**
3 (1)(a), (5.5), and (6); and **add** (40.5) as follows:".

4 Page 2, after line 5 insert:

5 (1) "Bingo" means:

6 (a) ~~A bingo strip card game; or~~

7 (5.5) ~~"Bingo strip card game" means a type of bingo that is played~~
8 ~~with a strip of up to five connected paper bingo cards, with each card~~
9 ~~containing a concealed grid of preprinted numbers ranging from one to~~
10 ~~seventy-five. The winner is the first player to match the numbers drawn~~
11 ~~on one or more bingo balls to the prearranged pattern of numbers on a~~
12 ~~card. The maximum prize for an individual card may not exceed one~~
13 ~~thousand dollars."~~

14 Page 3, after line 2 insert:

15 "(40.5) "STRIP BINGO GAME" MEANS A TYPE OF BINGO THAT IS
16 PLAYED WITH A STRIP CARD OF UP TO FIVE CONNECTED PAPER BINGO
17 FACES, WITH EACH BINGO FACE CONTAINING A CONCEALED GROUPING OF
18 PREPRINTED SYMBOLS, FREE SPACES, AND NUMBERS RANGING FROM ONE
19 TO SEVENTY-FIVE."

20 Page 30, after line 4 insert:

21 **"SECTION 21.** In Colorado Revised Statutes, 24-21-618, **add**
22 (11) as follows:

23 **24-21-618. Conduct of bingo games - strip bingo games.**

24 (11) IN THE CONDUCT OF ANY STRIP BINGO GAME OR ANY OCCASION THAT
25 INCLUDES A STRIP BINGO GAME:

26 (a) A BINGO-RAFFLE LICENSEE MAY USE ANY STYLE OF STRIP BINGO
27 GAME AUTHORIZED BY THIS PART 6 OR BY THE RULES ADOPTED PURSUANT
28 TO THIS PART 6;

29 (b) THE MAXIMUM PRIZE FOR AN INDIVIDUAL CARD THAT IS USED
30 AS PART OF A STRIP BINGO GAME MUST NOT EXCEED ONE THOUSAND
31 DOLLARS;

32 (c) BOTH STRIP BINGO GAMES AND TRADITIONAL BINGO GAMES
33 MAY BE PLAYED DURING THE SAME OCCASION; AND

1 (d) THE TOTAL AMOUNT OF PRIZES AWARDED FOR ALL BINGO
2 GAMES AT A SINGLE OCCASION MUST NOT EXCEED FIFTEEN THOUSAND
3 DOLLARS."

4 Renumber succeeding sections accordingly.

5 Page 37, after line 13 insert:

6 "SECTION 26. In Colorado Revised Statutes, 24-21-622, amend
7 (3)(a) as follows:

8 **24-21-622. Bingo-raffle licensee's statement of receipts -**
9 **expenses - fee - definitions.** (3) (a) All money collected or received from
10 the sale of admission, extra regular cards, bingo strip cards, special game
11 cards, sale of supplies, and all other receipts from the games of
12 TRADITIONAL AND STRIP bingo GAMES, raffles, and pull tab games shall
13 be deposited in a special checking or savings account, or both, of the
14 licensee, which must contain only this money. If the licensee conducts
15 progressive games of chance, the licensee may maintain one additional
16 checking or savings account, which must contain only money received
17 from the sale of progressive games. The licensee may withdraw money
18 from these accounts only by consecutively numbered checks or
19 withdrawal slips or by electronic transactions referenced by transaction
20 number or date. A check or withdrawal slip must not be drawn to "cash"
21 or a fictitious payee. The licensee shall maintain all of its books and
22 records in accordance with generally accepted accounting principles."

23 Renumber succeeding sections accordingly.

24 Page 48, line 7, strike "**this House Bill 24-____**," and substitute "**House**
25 **Bill 24-1326**,".

26 Page 49, strike line 1 and substitute "except that sections 2, 5, 7 through
27 17, 20, 22 through 25, 27 through 32, 36, 38, and 39 of".

28 Page 1, line 102, strike "**BINGO**,".

29 Page 1, strike lines 103 through 105 and substitute "**BINGO**,".
