1 Amend printed bill, page 2, before line 10 insert:

2 "SECTION 2. In Colorado Revised Statutes, 22-7-303, **amend**
3 (2)(c) and (2)(d); and **add** (2)(e) as follows:

4 **22-7-303. Colorado state advisory council for parent**
5 **involvement in education - created - membership.** (2) The council
6 shall consist of the following members:

7 (c) Two persons appointed by the executive director of the
8 department of higher education; ~~and~~

9 (d) A representative of the department of human services
10 appointed by the executive director of ~~said~~ THE department OF HUMAN
11 SERVICES; AND

12 (e) A REPRESENTATIVE OF THE DEPARTMENT OF EARLY CHILDHOOD
13 APPOINTED BY THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF EARLY
14 CHILDHOOD.

15 **SECTION 3.** In Colorado Revised Statutes, 22-7-304, **amend**
16 (1)(c), (1)(g), and (1)(h); and **add** (1)(i) as follows:

17 **22-7-304. Council - advisory duties - technical assistance -**
18 **report.** (1) The council shall inform, at a minimum, the early childhood
19 councils, public schools, school districts, the state charter school institute,
20 the department, the state board, the department of higher education, the
21 Colorado commission on higher education, and the governing boards for
22 the state institutions of higher education concerning best practices and
23 strategies, aligned with the national standards for family-school
24 partnerships, for increasing parent involvement in public education and
25 promoting family and school partnerships, including but not limited to
26 best practices and strategies in the following areas:

27 (c) Involving parents in ~~response to intervention programs~~ A
28 MULTI-TIERED SYSTEM OF SUPPORTS in public schools and school districts;

29 (g) Creating and implementing family-to-school liaison positions;
