SB24-092 be amended as follows:

- 1 Amend printed bill, page 2, lines 2 and 3, strike "**amend** (6); and".
- 2 Page 3, strike lines 12 through 18.
- 3 Page 3, strike lines 20 and 21 and substitute "THE GOVERNING BODY OF A
- 4 COUNTY IS NOT REQUIRED TO ADOPT ANY PROVISION OF AN ENERGY CODE
- 5 PURSUANT TO SUBSECTION (3.5) OF THIS SECTION UNTIL THE PROVISION
- 6 HAS BEEN DETERMINED TO BE COST-EFFECTIVE PURSUANT TO SECTION
- 7 24-38.5-401 (8)(f).".
- 8 Page 3, lines 22 and 23, strike "**amend** (6); and".
- 9 Page 4, strike lines 22 through 27.
- 10 Page 5, strike line 1.
- 11 Page 5, strike lines 3 and 4 and substitute "THE GOVERNING BODY OF A
- 12 MUNICIPALITY IS NOT REQUIRED TO ADOPT ANY PROVISION OF AN ENERGY
- 13 CODE PURSUANT TO SUBSECTION (3.5) OF THIS SECTION UNTIL THE
- 14 PROVISION HAS BEEN DETERMINED TO BE COST-EFFECTIVE PURSUANT TO
- 15 SECTION 24-38.5-401 (8)(f).".
- 16 Page 5, after line 4 insert:
- 17 "SECTION 3. In Colorado Revised Statutes, 24-38.5-401, **amend**
- 18 (10)(a); and **add** (8)(f) as follows:
- 19 **24-38.5-401. Energy code board - appointment - creation -**
- 20 **duties - definitions - repeal.** (8) (f) A MODEL ELECTRIC AND SOLAR
- 21 READY CODE AND MODEL LOW ENERGY AND CARBON CODE ADOPTED
- 22 PURSUANT TO THIS SECTION MUST BE COST-EFFECTIVE, AND A MODEL
- 23 ELECTRIC AND SOLAR READY CODE AND MODEL LOW ENERGY AND CARBON
- 24 CODE ADOPTED PURSUANT TO THIS SECTION AS OF JULY 1, 2024, SHALL BE
- 25 AMENDED TO BE COST-EFFECTIVE. FOR PURPOSES OF THIS SUBSECTION
- 26 (8)(f), "COST-EFFECTIVE" HAS THE SAME MEANING AS SET FORTH IN
- 27 SECTION 30-28-211 (2)(a.6).
- 28 (10) (a) **Reporting.** The Colorado energy office shall include an
- 29 update regarding the effectiveness of the energy code board in its 2027
- 30 report to the members of the applicable committees of reference in the
- 31 senate and house of representatives as required by the "State
- 32 Measurement for Accountable, Responsive, and Transparent (SMART)
- 33 Government Act", part 2 of article 7 of title 2. THE COLORADO ENERGY

1 OFFICE SHALL INCLUDE IN ITS UPDATE AN EVALUATION OF THE COST-
2 EFFECTIVENESS OF THE MODEL ELECTRIC AND SOLAR READY CODE AND
3 MODEL LOW ENERGY AND CARBON CODE ADOPTED PURSUANT TO THIS
4 SECTION.".
