

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB24-088 be amended as follows:

- 1 Amend printed bill, page 11, strike lines 7 through 27 and substitute:
2 "BOND APPROVED BY THE VOTERS IN THE PRECEDING FIVE BUDGET YEARS,
3 THE TOTAL AMOUNT OF THE BOND AND THE AMOUNT OF THE BOND
4 REVENUE THAT WAS EXPENDED ON LAND OR A FACILITY USED BY A
5 DISTRICT CHARTER SCHOOL;".
- 6 Page 12, strike line 1.
- 7 Page 12, line 9, strike "THE" and substitute: "BEGINNING WITH THE
8 REPORT SUBMITTED PURSUANT TO THIS SECTION IN THE 2024-25 BUDGET
9 YEAR, THE".
- 10 Page 12, line 13, strike "YEAR;" and substitute: "YEAR; EXCEPT THAT IF
11 THE INFORMATION IS AVAILABLE FOR ANY OR ALL OF THE PRECEDING FIVE
12 STATE FISCAL YEARS, THAT INFORMATION MUST ALSO BE REPORTED;".
- 13 Page 12, strike lines 17 through 19 and substitute: "CHARTER CONTRACT
14 TERM AND THE RATIONALE FOR DETERMINING THE APPROVED DURATION
15 OF EACH CHARTER CONTRACT TERM THAT IS LESS THAN THE PROPOSED
16 CHARTER CONTRACT TERM IN THE CHARTER SCHOOL APPLICATION;".
- 17 Page 13, strike lines 3 through 8 and substitute:
18 "(B) THE INFORMATION PROVIDED PURSUANT TO THIS SUBSECTION
19 (4)(h)(III) MUST INCLUDE THE PRECEDING FIVE STATE FISCAL YEARS;".
- 20 Page 13, strike lines 9 through 11 and substitute:
21 "(IV) A DESCRIPTION OF THE MANNER IN WHICH INFORMATION ON
22 THE CHARTER SCHOOL APPLICATION PROCESS IS PUBLISHED AND
23 DISTRIBUTED.".
- 24 Page 13, strike lines 12 through 14.
- 25 Page 14, line 15, strike "THE" and substitute: "BEGINNING WITH THE
26 REPORT SUBMITTED PURSUANT TO THIS SECTION IN THE 2024-25 BUDGET
27 YEAR, THE".
- 28 Page 14, line 18 and 19, strike "TEN BUDGET YEARS;" and substitute: "
29 STATE FISCAL YEAR; EXCEPT THAT IF THE INFORMATION IS AVAILABLE FOR
30 ANY OR ALL OF THE PRECEDING FIVE STATE FISCAL YEARS, THAT
31 INFORMATION MUST ALSO BE REPORTED;".
- 32 Page 14, strike line 22 and substitute: "SUBSECTION (4)(j).".
- 33 Page 14, strike lines 23 and 24.
