HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

HB24-1029 be amended as follows:

- 1 Amend printed bill, page 2, line 6, strike "**exemption -**".
  
- 2 Page 3, lines 13 through 15, strike "THE PEOPLE'S REPUBLIC OF CHINA,  
3 THE RUSSIAN FEDERATION, OR ANY COUNTRY THAT IS ON THE LIST OF  
4 STATE SPONSORS OF TERRORISM." and substitute "ANY COUNTRY  
5 DESIGNATED AS A "FOREIGN ADVERSARY" OR A "STATE SPONSOR OF  
6 TERRORISM" BY THE UNITED STATES DEPARTMENT OF STATE, THE UNITED  
7 STATES DEPARTMENT OF COMMERCE, THE UNITED STATES DEPARTMENT  
8 OF ENERGY, OR ANY OTHER CABINET-LEVEL OFFICIAL OF THE UNITED  
9 STATES GOVERNMENT, INCLUDING ANY COUNTRY DESCRIBED IN 15 CFR  
10 7.4 (a), AS AMENDED, AND ANY COUNTRY THAT IS ON THE LIST OF STATE  
11 SPONSORS OF TERRORISM."
  
- 12 Page 5, line 24, strike "PERSON'S" and substitute "ENTITY'S OR COVERED  
13 FOREIGN GOVERNMENT'S".
  
- 14 Page 5, strike lines 25 through 27 and substitute "ENTITY OR COVERED  
15 FOREIGN GOVERNMENT ON OR AFTER JANUARY 1, 2025, BECAUSE THE  
16 ENTITY'S OR GOVERNMENT'S COUNTRY HAS BEEN DESIGNATED AS A  
17 "FOREIGN ADVERSARY" OR A "STATE SPONSOR OF TERRORISM", THE  
18 COVERED FOREIGN ENTITY'S OR COVERED FOREIGN GOVERNMENT'S  
19 CHANGE IN STATUS OCCURS ON THE EFFECTIVE DATE OF THE  
20 DESIGNATION."
  
- 21 Page 6, strikes lines 1 and 2.
  
- 22 Page 8, strike lines 3 through 8.
  
- 23 Strike "PERSON" and substitute "ENTITY OR COVERED FOREIGN  
24 GOVERNMENT" on: **Page 3**, line 10; **Page 4**, lines 17 and 20; **Page 5**, lines  
25 9, 13, 14, 20 two times, and 22; and **Page 7**, line 9.
  
- 26 Strike "A PERSON" and substitute "AN ENTITY OR A GOVERNMENT" on:  
27 **Page 5**, lines 17 and 24.
  
- 28 Page 1, line 102, after "BY" insert "CERTAIN".
