Committee on Energy & Environment.

HB24-1346 be amended as follows:

- 14 (d) PROTECTING DISPROPORTIONATELY IMPACTED COMMUNITIES
- 15 AND ADVANCING ENVIRONMENTAL JUSTICE; AND
- 16 (e) THE SAFE AND RESPONSIBLE USE OF COLORADO'S ABUNDANT
- 17 NATURAL RESOURCES FOR THE PERMANENT STORAGE OF CARBON
- 18 DIOXIDE."
