SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB26-037 be amended as follows:

1 Amend printed bill, page 2, line 22, after "WEEKEND" insert "AND  
2 HOLIDAY".

3 Page 3, line 1, after "WEEKEND" insert "AND HOLIDAY".

4 Page 3, line 3, after "WEEKEND" insert "AND HOLIDAY".

5 Page 3, after line 7 insert:

6           "(c) WHEN A CHIEF JUDGE ELECTS TO UTILIZE JUDICIAL OFFICERS  
7 FROM THEIR OWN JUDICIAL DISTRICT TO PRESIDE OVER WEEKEND AND  
8 HOLIDAY BOND HEARINGS WITH THE SUPPORT OF BOND HEARING OFFICER  
9 STAFF PURSUANT TO THIS SUBSECTION (2.5), THE DISTRICT SHALL  
10 CONDUCT THE HEARINGS DURING THE TIME SLOT ASSIGNED TO THAT  
11 JUDICIAL DISTRICT UNDER THE EXISTING STATEWIDE WEEKEND AND  
12 HOLIDAY BOND HEARING SCHEDULE UTILIZED FOR BOND HEARING  
13 OFFICERS. A JUDICIAL DISTRICT SHALL NOT ALTER ITS ASSIGNED WEEKEND  
14 AND HOLIDAY BOND HEARING TIME SLOT WHEN ELECTING TO UTILIZE ITS  
15 OWN JUDICIAL OFFICERS. A JUDICIAL DISTRICT SHALL NOT HAVE ITS OWN  
16 JUDICIAL OFFICERS CONDUCT WEEKEND AND HOLIDAY BOND PROCEEDINGS  
17 SIMULTANEOUS TO OTHER BOND PROCEEDINGS BEING CONDUCTED BY THE  
18 BOND HEARING OFFICER STAFF THAT WOULD HAVE HEARD THE  
19 PROCEEDING HAD THE CHIEF JUDGE NOT ELECTED TO USE THEIR OWN  
20 JUDICIAL OFFICERS.

21           (d) IF A JUDICIAL DISTRICT ELECTS TO UTILIZE ITS OWN JUDICIAL  
22 OFFICERS TO PRESIDE OVER WEEKEND AND HOLIDAY BOND HEARINGS  
23 PURSUANT TO THIS SUBSECTION (2.5), THE CHIEF JUDGE OF THE JUDICIAL  
24 DISTRICT SHALL DESIGNATE, ON AN ANNUAL BASIS, WHETHER THE  
25 DISTRICT WILL UTILIZE BOND HEARING OFFICERS OR JUDICIAL OFFICERS  
26 FROM THE DISTRICT TO PRESIDE OVER THE BOND HEARINGS. THE  
27 DESIGNATION MUST REMAIN IN EFFECT FOR THE ENTIRE CALENDAR YEAR  
28 AND MUST NOT BE CHANGED DURING THAT YEAR."
