HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB26-1226 be amended as follows:

1 Amend printed bill, page 4, line 16, after "**reports -**" insert
2 "**recommendations to the general assembly -**".

3 Page 5, line 5, strike "NO LATER THAN DECEMBER 31, 2029," and
4 substitute "IN DECEMBER 2029,".

5 Page 6, after line 14 insert:

6 "(5) (a) ON AUGUST 1, 2029, THE COMMISSION SHALL SUBMIT TO
7 THE GENERAL ASSEMBLY A LIST OF ANY COVERED ELECTRIC GENERATING
8 UNITS THAT ARE SUBJECT TO AN ORDER ISSUED BY THE UNITED STATES
9 DEPARTMENT OF ENERGY UNDER SECTION 202 (c) OF THE FEDERAL POWER
10 ACT.

11 (b) IF THERE ARE ANY COVERED ELECTRIC GENERATING UNITS
12 THAT, AS OF THE DATE OF THE SUBMISSION OF THE LIST DESCRIBED IN
13 SUBSECTION (5)(a) OF THIS SECTION, ARE SUBJECT TO AN ORDER ISSUED BY
14 THE UNITED STATES DEPARTMENT OF ENERGY UNDER SECTION 202 (c) OF
15 THE FEDERAL POWER ACT, THE COMMISSION SHALL ALSO SUBMIT ALONG
16 WITH THE LIST DESCRIBED IN SUBSECTION (5)(a) OF THIS SECTION
17 RECOMMENDATIONS TO THE GENERAL ASSEMBLY FROM STAKEHOLDERS,
18 INCLUDING UTILITIES THAT OWN OR OPERATE COVERED ELECTRIC
19 GENERATING UNITS, REGARDING WHETHER TO AMEND THIS SECTION,
20 INCLUDING WHETHER TO POSTPONE THE EARLIEST COMPLIANCE DEADLINE
21 DESCRIBED IN SUBSECTION (2)(d) OF THIS SECTION OR ENACT ANY OTHER
22 AMENDMENTS REGARDING COVERED ELECTRIC GENERATING UNITS
23 SUBJECT TO AN ORDER ISSUED UNDER SECTION 202 (c) OF THE FEDERAL
24 POWER ACT.".

25 Page 9, lines 14 and 15, strike "A PORTFOLIO THAT CONSISTS IN WHOLE OR
26 IN PART" and substitute "OR MODIFYING A PORTFOLIO IN AN ELECTRIC
27 RESOURCE PLAN OR ANY RELATED PROCEEDING IN WHICH THE COMMISSION
28 EVALUATES THE ACQUISITION".

29 Page 9, lines 17 and 18, strike "A TOTAL" and substitute "AN".

30 Page 9, lines 19 and 20, strike "IS SUFFICIENT FOR" and substitute
31 "ENABLES".
