HB26-1107 be amended as follows:

- 1 Amend printed bill, page 3, after line 7 insert:
2 "SECTION 2. In Colorado Revised Statutes, 12-255-104, **add**
3 (9)(b)(IV) as follows:
4 **12-255-104. Definitions.**
5 As used in this article 255, unless the context otherwise requires:
6 (9) (b) "Practice of practical nursing" includes:
7 (IV) THE ADMINISTRATION OF MEDICATION BY INJECTION IF THE
8 LICENSED PRACTICAL NURSE COMPLETES EDUCATION AND TRAINING
9 REQUIREMENTS ESTABLISHED PURSUANT TO RULES ADOPTED BY THE
10 BOARD IN ACCORDANCE WITH SECTION 12-255-107 (1)(a)(III).
11 **SECTION 3.** In Colorado Revised Statutes, 12-255-107, **add**
12 (1)(a)(III) and (1)(a)(IV) as follows:
13 **12-255-107. Powers and duties of the board - rules - definition.**
14 (1) The board has the following powers and duties:
15 (a) (III) (A) TO ADOPT RULES THAT ESTABLISH EDUCATION AND
16 TRAINING REQUIREMENTS FOR ADMINISTERING MEDICATION BY INJECTION
17 PERFORMED BY A LICENSED PRACTICAL NURSE IN ACCORDANCE WITH
18 SECTION 12-255-104 (9)(b)(IV); BY A CERTIFIED NURSE AIDE IN
19 ACCORDANCE WITH SECTION 12-255-206 (1)(f); OR BY A CERTIFIED
20 MEDICATION AIDE IN ACCORDANCE WITH SECTION 12-255-208 (1).
21 (B) THE RULES ADOPTED BY THE BOARD PURSUANT TO THIS
22 SUBSECTION (1)(a)(III) MAY REQUIRE A LICENSED PRACTICAL NURSE,
23 CERTIFIED NURSE AIDE, OR CERTIFIED MEDICATION AIDE TO ADMINISTER
24 MEDICATION BY INJECTION ONLY UNDER THE SUPERVISION OF A
25 REGISTERED NURSE; EXCEPT THAT THE BOARD SHALL NOT REQUIRE
26 IN-PERSON SUPERVISION.
27 (IV) TO APPROVE EDUCATION AND TRAINING PROGRAMS IN
28 ACCORDANCE WITH SUBSECTION (1)(a)(III) OF THIS SECTION."

31 Page 13, strike lines 1 through 14.
32 Renumber succeeding section accordingly
33 Strike "PART 3 OF ARTICLE 1.5 OF TITLE 25." and substitute "RULES

35 AND (1)(a)(IV)." on: **Page 3**, line 18; and **Page 4**, lines 10 and 11.
