HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation, Housing & Local Government.

SB26-040 be amended as follows:

- 1 Amend reengrossed bill, page 4, lines 10 and 11 strike "and tribal  
2 governments" and substitute "~~and tribal governments~~".
  
- 3 Page 6, line 7, strike "or tribal government" and substitute "~~or tribal  
4 government~~".
  
- 5 Page 6, line 17 strike "tribal governments," and substitute "~~tribal  
6 governments,~~".
  
- 7 Page 6, line 22 strike "OR TRIBAL GOVERNMENT".
  
- 8 Page 7, line 14 strike "or tribal government" and substitute "~~or tribal  
9 government~~".
  
- 10 Page 8, after line 10 insert:  
11 "(III) FOR GRANTS TO SUPPORT TRIBAL GOVERNMENT PROGRAMS,  
12 THE TRIBE SHALL ESTABLISH LIMITATIONS ON HOUSEHOLD INCOME AND  
13 MAXIMUM PERCENTAGE OF INCOME THAT A HOUSEHOLD MAY ALLOCATE  
14 FOR MONTHLY HOUSING COSTS REQUIRED BY SUBSECTION (3)(a)(I) OF THIS  
15 SECTION AND SHALL ESTABLISH A TRIBAL AFFORDABILITY MECHANISM IN  
16 LIEU OF ANY STATE-PREScribed USE COVENANT. THE TRIBAL  
17 GOVERNMENT SHALL SUBMIT EVIDENCE TO THE DIVISION THAT IT HAS  
18 SATISFIED THE REQUIREMENTS OF THIS SUBSECTION (3)(a)(III), INCLUDING  
19 BY PROVIDING GENERAL INFORMATION ABOUT THE PROCESS IT USED TO  
20 ESTABLISH THESE LIMITATIONS AND MECHANISMS BUT IS NOT REQUIRED  
21 TO DISCLOSE CONFIDENTIAL TRIBAL DATA, INCLUDING THE SPECIFIC  
22 LIMITATIONS OR MECHANISMS IT SETS UNDER THIS SUBSECTION. UNLESS  
23 OTHERWISE AUTHORIZED BY LAW, THE DIVISION OF HOUSING AND THE  
24 DIVISION OF LOCAL GOVERNMENT SHALL ADMINISTER AND EXPEND  
25 FUNDING TO TRIBAL GOVERNMENTS UNDER THIS SECTION ONLY FOR THE  
26 PURPOSES SET FORTH IN SECTIONS 29-32-104 (3)(a), (3)(b), OR (3)(c)."
  
- 27 Page 9, strike line 12 and substitute "FINANCIAL INSTITUTION OR  
28 COMMUNITYLAND".
  
- 29 Page 11, strike line 2.
