

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB26-1326 be amended as follows:

1 Amend printed bill, page 36, strike lines 4 through 27.

2 Strike pages 37 through 40.

3 Page 41, strike lines 1 through 5 and substitute:

4 "SECTION 35. In Colorado Revised Statutes, 40-2-113, **add** (4)
5 as follows:

6 **40-2-113. Collection of fees - limitation - filing fees.**

7 (4) (a) EXCEPT AS PROVIDED IN SUBSECTION (4)(b) OF THIS
8 SECTION, THE COMMISSION MAY SET ADMINISTRATIVELY A FILING FEE
9 SCHEDULE FOR APPLICATIONS, PETITIONS, REGISTRATIONS, FORMAL
10 COMPLAINTS, AND SIMILAR FILINGS THAT ARE SUBMITTED TO THE
11 COMMISSION THAT RELATE TO COMMUNICATIONS SERVICES,
12 TELECOMMUNICATIONS SERVICES, AND BASIC EMERGENCY SERVICES. THE
13 PURPOSE OF THE FILING FEES IS TO RECOVER THE COMMISSION'S COSTS
14 ASSOCIATED WITH REGULATORY ACTIVITIES THAT ARE NOT COVERED BY
15 THE FEES ASSESSED PURSUANT TO SECTIONS 40-2-112 AND 40-2-113.

16 (b) MEMBERS OF THE PUBLIC WHO FILE COMPLAINTS AND PUBLIC
17 UTILITIES THAT ARE SUBJECT TO THE FEES ASSESSED PURSUANT TO
18 SECTIONS 40-2-112 AND 40-2-113 ARE EXEMPT FROM THE FILING FEES SET
19 PURSUANT TO SUBSECTION (4)(a) OF THIS SECTION.

20 (c) THE STATE TREASURER SHALL CREDIT ALL FILING FEES
21 COLLECTED BY THE COMMISSION PURSUANT TO THIS SUBSECTION (4) TO
22 THE TELECOMMUNICATIONS UTILITY FUND CREATED IN SECTION 40-2-114
23 (1)(b)(I).

24 **SECTION 36.** In Colorado Revised Statutes, 40-15-402, **amend**
25 (1) as follows:

26 **40-15-402. No regulation by the commission - no certificate**
27 **required.**

28 (1) Nothing in articles 1 to 7 of this ~~title~~ TITLE 40 or parts 2 and
29 3 of this ~~article~~ ARTICLE 15 ~~shall apply~~ APPLIES to deregulated services
30 and products pursuant to this part 4; EXCEPT THAT THE FILING FEES SET
31 ADMINISTRATIVELY BY THE COMMISSION PURSUANT TO SECTION 40-2-113
32 (4) APPLY TO DEREGULATED SERVICES AND PRODUCTS."
