

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB26-003 be amended as follows:

- 1 Amend reengrossed bill, page 15, strike lines 3 through 8 and substitute:
2 "(e) PROVIDE A LINK ON THE DEPARTMENT'S PUBLIC WEBSITE TO
3 A DIGITAL REGISTRATION FORM THAT AN ENTITY CAN USE TO REGISTER
4 PURSUANT TO SECTION 25-17-1019 (1);".
- 5 Page 17, line 6, strike "SECONDARY HANDLER, REMANUFACTURER," and
6 substitute "REMANUFACTURER".
- 7 Page 17, lines 10 and 11, strike "SECONDARY HANDLER,
8 REMANUFACTURER," and substitute "REMANUFACTURER".
- 9 Page 17, after line 12 insert:
10 "(c) BEFORE AN UNWANTED PROPULSION BATTERY IS COLLECTED
11 FROM A SECONDARY HANDLER BY A PROPULSION BATTERY PROVIDER OR
12 REMANUFACTURER, THE SECONDARY HANDLER SHALL REGISTER WITH THE
13 DEPARTMENT BY PROVIDING TO THE DEPARTMENT, THROUGH INFORMAL
14 DIGITAL CORRESPONDENCE OR BY SUBMITTING A DIGITAL FORM, THE
15 SECONDARY HANDLER'S BUSINESS NAME, CONTACT INFORMATION,
16 ADDRESS, AND BUSINESS DESCRIPTION. A SECONDARY HANDLER IS NOT
17 REQUIRED TO PAY THE REGISTRATION FEE.".
- 18 Page 17, line 26, strike "REGISTRATION;" and substitute "REGISTRATION,
19 INCLUDING A LINK TO THE REGISTRATION FORM CREATED BY THE
20 DEPARTMENT PURSUANT TO SECTION 25-17-1015 (2)(e);".
- 21 Page 18, lines 25 and 26, strike "INFORMATION, IF AVAILABLE;" and
22 substitute "INFORMATION;".
- 23 Page 25, lines 26 and 27, strike "INFORMATION, IF AVAILABLE." and
24 substitute "INFORMATION.".
- 25 Page 26, line 19, strike "WERE OFFERED" and substitute "NEEDED TO BE
26 COLLECTED".
- 27 Page 26, lines 23 and 24, strike "OFFERED THE UNWANTED PROPULSION
28 BATTERY, ALONG WITH" and substitute "NOTIFIED THE PROPULSION
29 BATTERY PROVIDER OR REMANUFACTURER THAT THE UNWANTED
30 PROPULSION BATTERY NEEDED TO BE COLLECTED AND PROVIDED".
- 31 Page 26, strike line 26 and substitute "SECTION;".
