INTERIM COMMITTEE AMENDMENT  
Legislative Oversight Committee Concerning Colorado Jail Standards.  
BY REPRESENTATIVE Amabile  
LLS No. 24-0525.01 be amended as follows:

- 1 Amend LLS No. 24-0525.01, page 5, strike lines 26 and 27.
- 2 Page 6, strike lines 1 through 6.
- 3 Renumber succeeding sections accordingly.
- 4 Page 6, line 16, strike "JAIL." and substitute "JAIL, AND THE ATTORNEY  
5 GENERAL MAY CONDUCT THE SPECIAL ASSESSMENT OF THE JAIL."
- 6 Page 6, line 20, strike "SHALL" and substitute "MAY".
- 7 Page 6, line 25, strike "OF" insert "FOR EACH OF".
- 8 Page 6, line 26, strike "(1)(b), (1)(c), AND (1)(d)" and substitute "(1)(b)  
9 AND (1)(c)".
- 10 Page 7, line 2, after "LOCATED," insert "THE COUNTY SHERIFFS OF  
11 COLORADO,".
- 12 Page 7, strike lines 7 and 8 and substitute "MAY RELEASE A REPORT AT  
13 THE ATTORNEY GENERAL'S DISCRETION AND A COUNTY SHERIFF MAY  
14 RELEASE A REPORT RELATING TO THE COUNTY SHERIFF'S JAIL AFTER  
15 CONSULTATION WITH THE ATTORNEY GENERAL'S OFFICE."
- 16 Page 7, line 15, after "RECEIVED" insert "THROUGH THE COMPLAINT  
17 PROCESS AS DESIGNATED BY THE ATTORNEY GENERAL'S OFFICE".
- 18 Page 7, after line 18, insert:  
19 "(5) SECTIONS 2-3-1901, 2-3-1901.5, 24-31-117, AND 30-10-529  
20 DO NOT IN ANY WAY LIMIT OR RESTRICT THE ATTORNEY GENERAL'S  
21 AUTHORITY TO INVESTIGATE PATTERNS OR PRACTICES PURSUANT TO  
22 SECTION 24-31-113, INCLUDING BUT NOT LIMITED TO ANY  
23 NONCOMPLIANCE WITH JAIL STANDARDS THAT CONSTITUTE A PATTERN OR  
24 PRACTICE OF CONDUCT THAT DEPRIVES PERSONS OF RIGHTS, PRIVILEGES,  
25 OR IMMUNITIES SECURED OR PROTECTED BY THE CONSTITUTION OR LAWS  
26 OF THE UNITED STATES OR THE STATE OF COLORADO."
- 27 Renumber succeeding subsection accordingly.
