HB23-1108 be amended as follows:

- 1 Amend printed bill, page 3, strike line 7.
- 2 Reletter subsequent paragraphs accordingly.

- 4 Reletter subsequent paragraphs accordingly.
- 5 Page 4, line 4, strike "AND".
- 6 Page 4, after line 5, add:
 - 7 "(p) A REPRESENTATIVE FROM A STATEWIDE ORGANIZATION THAT
 - 8 TREATS CHILDREN WHO ARE VICTIMS OF DOMESTIC VIOLENCE AND
 - 9 PROVIDES EXPERTISE ON THE PREVENTION OF CHILD ABUSE AND NEGLECT;
 - 10 (q) A MEMBER OF LAW ENFORCEMENT THAT WORKS DIRECTLY
 - 11 WITH VICTIMS OF CHILD ABUSE OR NEGLECT AND DOMESTIC VIOLENCE;
 - 12 (r) TWO PRIVATE CRIMINAL DEFENSE ATTORNEYS WITH
 - 13 EXPERIENCE REPRESENTING A VICTIM OF DOMESTIC VIOLENCE OR SEXUAL
 - 14 ASSAULT;
 - 15 (s) A REPRESENTATIVE OF THE OFFICE OF STATE PUBLIC DEFENDER
 - 16 WITH EXPERIENCE REPRESENTING A VICTIM OF DOMESTIC VIOLENCE OR
 - 17 SEXUAL ASSAULT; AND
 - 18 (t) A SURVIVOR OF TRAUMATIC BRAIN INJURY.
 - 19 (4) THE CHIEF JUSTICE OF THE COLORADO SUPREME COURT SHALL
 - 20 APPOINT THE FOLLOWING MEMBERS TO SERVE ON THE TASK FORCE:
 - 21 (a) A STATE COURT JUDGE;
 - 22 (b) AN INDIVIDUAL OTHER THAN A JUDGE WHO IS COURT
 - 23 PERSONNEL;
 - 24 (c) A DISTRICT COURT JUDGE WITH EXPERIENCE IN DOMESTIC
 - 25 MATTERS;
 - 26 (d) A COUNTY COURT JUDGE; AND
 - 27 (e) A JUDGE FROM A RURAL COUNTY."
- 28 Renumber subsequent subsections accordingly.
- 29 Page 4, line 15, strike "PROGRAMS." and substitute "PROGRAMS AND THE
- 30 CHIEF JUSTICE OF THE COLORADO SUPREME COURT."
- 31 Page 4, line 16, after "PROGRAMS" add "AND THE CHIEF JUSTICE OF THE
- 32 COLORADO SUPREME COURT".
- 33 Page 4, line 19, after "PROGRAMS" add "AND THE CHIEF JUSTICE OF THE
- 34 COLORADO SUPREME COURT".
- 35 Page 4, line 21, strike "(9)" and substitute "(10)".
- 36 Page 6, line 3, strike "(9)" and substitute "(10)".
