



The Evil, the Stupid, the Inconsiderate, the Dumb, the Overzealous, Les Miserable and Holocaust a la Colorado

If you are a psychopath and you want to kidnap ~~your~~ child from his Mom, Colorado, USA is the place to do it. There is a system in place to help you do just that. Begin by butchering the child emotionally at an early age by slandering his mother, claiming that she is mentally ill, and the only way to deal with her is to call 911. On several occasions when Mom called Jefferson County Human Services and the Lakewood Police, complaining that her little boy came home saying, "Dad said, you are mentally ill"; Dad said you are a bad person because he has to give you money"; Dad said, "If I do bad things to you I am a good boy"; Dad said, "I do not have to listen to you"; or Dad said, "You are abusing me?" Mom was told by JCHS, "This is a free country. We do not tell our citizens how to raise their children?" "You're telling me!" said Mom. And by the Lakewood Police that it is not a crime for one parent to make accusations about the other parent.

In 2003 Mom told her little boy that he could not go to the neighbor's house. (That person died in 2007 from a drug overdose) The child had a fit, threw things at his Mom, picked up a scissors and then called his father. "Dad said you are a F.B and he is calling the police"; said the boy. Instead of telling the child to listen to his Mom and discussing the problem with the Dad, the Lakewood Police arrested Mom. All this was before they even talked to the child, while she was in the hallway of her condo talking to her boyfriend of 12 years about the police being called. The police handed the child over to Dad and the child and the police had a conversation about Mom being "crazy." The child was being kidnapped with the help of the police. In a later incident, Dad told the child not to listen to Mom and to go to the neighbor's house regardless of what Mom says. The child ran to the neighbor's house. Dad called the police and picked up the child once again. The kidnapping by the police and the father continued and the mother had no place to go, since the police were helping Dad.

On 1/2/04 the boy told his Mom to get a job because his Dad was sick of giving her money and the boy hit his Mom several times with a wet rag. While washing dishes, Mom splashed the boy with water several times and accidentally hit the boy with a wet dish rag, on the shoulder. She then took the garbage out, and the boy called the police, per Dad's instructions. Dad came to pick up the child again. The mother cried, "Goodbye my little boy," knowing the child was being kid-napped by Dad and the State of Colorado. JCHS got involved and Mom was charged with child abuse the next day. She was treated by everyone as a criminal. Dad got temporary custody. Mom had no access to her little boy, and tried to explain to Michelle Principatto of the Special Unit for Crimes against Children (SUFAC) that Dad was the one that was using and abusing the child, but Mom got laughed at. Mom read in the JCHS report that Dad told Ms. Principatto that Mom has a history of mental health issues, and she is dangerous. Ms. Principatto told this to the Social Worker and also told her not to meet with Mom in person. She also claimed that Mom had "sicked" the dog on her when, in fact, the dog just simply barked after she left. None of the "professionals mentioned Parental Alienation Syndrome (PAS) Mom discovered the research on the internet in 2007. She called Sergeant Tinley of Lakewood Police Department's SUFAC unit, and asked him if he was familiar with PAS. He said, "Not really." In 2008, one of the female officers in LP's SUFAC claimed she was "very familiar" with Obsessed Alienator Syndrome (there is no such thing). Mom had supervised visits at Jeffco for awhile, but then Dad tells JCHS that the child doesn't want to see Mom. When Mom tried to talk to her son, Dad screams in the background. "She is a bad mother and she is abusing you." The boy starts calling Mom a "whore" and a "f.bitch", with Dad laughing in the background. Mom ends up not seeing her child for over a year, in spite of pleading with the Director of Child Protection, Jody Martinez on the State Level. Mom calls Gov. Ritter and she is told there is special task force being formed to look at PAS but Mom is never contacted by anyone despite several calls.

Magistrate. K.J. Moore takes custody from Mom, in spite of the Mom's testimony that Dad is very violent. He has beaten her, kicked her, thrown her down the stairs, hit her on the head with a board, left her on Hwy 285 when nine months pregnant as punishment for getting sick in the car. He woke her up with blasts of stereo music while she was pregnant, refused to bring her and the baby home from the hospital after childbirth, attacked her and her girlfriend who had brought her home, in front of her daughter, his young children, and the baby, and sued her for custody. For four years, Dad refused visitations, while Mom continued filing for contempt of the court, and K.J. Moore responded, "There is no change in the circumstances." Mom, a daughter of Holocaust survivors, experiences her own Holocaust. Mom filed for an emergency hearing, because her boy was self mutilating himself at Dads house. K.J. Moore denies the motion, saying, "There is no immediate danger to the child." Mom filed for custody, and the child was allowed three (happy) visits. Julie Jarvis of Arapahoe County Human Services got involved, after Mom called the police one day when the boy called her, extremely emotional, with Dad screaming in the background. Without talking to Mom, Ms. Jarvis determined that Mom is bad and automatically stipulates that Mom have only supervised visitations. Dad and Ms. Jarvis then encouraged several supervising agencies, including Karlis and Central Visitations to not let Mom see the child.

Dad filed for an emergency hearing to stop visitations and claimed that Mom had left him hateful messages in the past and he then presented some examples of conversations Mom had had with the child. It is not signed by the child, but K.J. Moore grants the father's motion, intimidates Mom and calls her mentally ill., and followed Jarvis suggestions for supervised visitations. K.J. Moore then becomes a judge. Mom gets arrested for violating the restraining order, after calling Dad's house trying to talk to her boy. She did not know she had a restraining order, since, as she later learned, a police officer had thrown the papers in the back seat of her car while she was stopped at the red light with her "ever-barking" German Sheppard Chow mix. The police officer claimed she had seen him, yet he could not tell her what color hat she was wearing. Mom then spends seven days in jail, and gets injured by leg cuffs while being transported from Jefferson County to Arapahoe County. Her boyfriend bailed her out after he got back to town. On July 29th Magistrate Voisinnet presided over the custody hearing during which Julie Jarvis blamed the Mom for the boy's self mutilation. Jarvis claimed she was "very familiar" with PAS, but could not name even one researcher and she did not know what the cure is for an Obsessed Alienator. Magistrate Voisinnet ignores Ms. Jarvis' lack of knowledge, or simply doesn't know about PAS himself. Research on Pas has proved that children self mutilate themselves due to the Obsessed Alienator's emotional abuse, when they express a desire to see the Target Parent. {In this case, this is "Mom"} Voisinnet was "enamored" with Dad and ordered supervised visitation for Mom following K.J. Moore's precedent. {Note, Magistrate Voisinnet has his chambers next to Judge K.J. Moore.}

The return of custody to the mother was denied, despite Dad having refused court-ordered visitation for four years. On 8-4-08, when finally there was a contempt of court hearing, Magistrate Voisinnet states, "It is not a big deal" regarding Dad's refusal for Mom to see her boy for four years and he stopped short of calling the mother a(?) Mom filed an appeal with Judge Enquist, but the records were incomplete so she ordered a new custody trial but refused to hear the case herself in spite of the fact that Mom informed her that Voisinnet is hateful is biased. Voisinnet was not interested in the testimony of the visitation supervisor who had observed the child's disrespect for his mother and who testified the Mom is a loving and carrying mother and that the child is very programmed by the father. Voisinnet called the Visitation Supervisor a lay person. He also ignored Mom's character witnesses. Voisinnet chose to blame Mom and her "behavior" for the child referring to her as his "biological" mother. He called Mom "dangerous", in spite of the Dad having tried to kill her with the car in 1996. Reckless endangerment charges were dismissed by Judge Frances Jackson. The fact that the father had attempted to assault her in the summer of 2007 when she came to see her son, didn't seem to alter his view of her. On Christmas Day of 2007, having brought gifts for her son, the father's adult children called her names in front of her son, called the police on her, and encouraged her son to push her.

Magistrate Voisinnet made a mockery out of justice and his office by lying. He admitted evidence such as the father's writings about his own mental and emotional problems he has had since childhood, as well as the boy's poems explaining that he is a hostage in his father's house. Yet, this evidence was returned, after the trial, marked "not admitted." Judge Enquist found nothing wrong with that, either Mom presents proof of her mental health after undergoing a psychological evaluation. Mom's motions to have Dad undergo the psychological evaluation, as she had done, were denied twice by Voisinnet.. Voisinnet puts on a show, saying that Dad should squash the subpoena for the boy to testify. In his orders, he blames Mom for having issued a subpoena. Not able to grant the "beheaded head" of the mother to the predator, Voisinnet granted his request for the son to now visit his mother when he wants to do so. Magistrate Voisinnet ignored the fact that Mom has been victimized by "Dad", and demeaned in front of her son and his adult siblings. They have screamed at her and called the police on her. Dad has refused to allow the visitation ordered by the court. The courts have refused to acknowledge that the boy is manipulated and coerced not to see Mom.

To appear impartial, Voisinnet appointed the Child Family Investigator, Doris Waters of 143 Union Blvd. Ste. #900; Lakewood (who has a resume' of serving on some board against violence and exploitation of women), and who called only one person out of eight Mom gave her as character witnesses. She also ignored the written suggestions by the former Visit Supervisor, ignored issues of violence against Mom, and agreed with Voisinnet. Originally, Mom and Dad were supposed to split the cost of CFI, but since Mom was indigent, Magistrate Voisinnet also excused Dad from paying; Therefore, Dad's portion was also paid by taxpayers, per Magistrate Voisinnet's orders. "Good- by, my little innocent boy." The Predator and officials of the State of Colorado have succeeded in turning your beautiful life in to (as you wrote) "Welcome to my damp cell, welcome to my Hell". Please remember the times with Mom when you wrote, "I remember the times when my life was full of poems and rhymes".
