

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

HB23-1230 be amended as follows:

1 Amend printed bill, page 10, strike lines 12 through 27.

2 Strike pages 11 through 13 and substitute:

3 **"18-12-603. Unlawful manufacture, import, or sale of bump**
4 **stocks prohibited.** A PERSON COMMITS THE OFFENSE OF UNLAWFUL
5 MANUFACTURE, IMPORT, OR SALE OF BUMP STOCKS IF THE PERSON
6 KNOWINGLY MANUFACTURES, IMPORTS, SELLS, OR OFFERS TO SELL, OR
7 KNOWINGLY CAUSES THE MANUFACTURE, IMPORTATION, OR SALE OF, A
8 BUMP STOCK.

9 **18-12-604. Penalties - civil.** (1) A PERSON WHO VIOLATES
10 SECTION 18-12-603 ON OR AFTER JULY 1, 2023, SHALL BE ASSESSED A
11 CIVIL PENALTY AS FOLLOWS:

12 (a) FOR VIOLATIONS OCCURRING BETWEEN JULY 1, 2023, AND
13 DECEMBER 31, 2023, THE PERSON SHALL BE ASSESSED A ONE THOUSAND
14 DOLLAR CIVIL PENALTY FOR EACH VIOLATION; AND

15 (b) FOR VIOLATIONS OCCURRING ON OR AFTER JANUARY 1, 2024,
16 THE PERSON SHALL BE ASSESSED A FIVE THOUSAND DOLLAR CIVIL
17 PENALTY FOR EACH VIOLATION.

18 (2) A LICENSED GUN DEALER, LICENSED FIREARMS DEALER, GUN
19 SHOW VENDOR, OR PERSON ATTEMPTING TO SELL OR WHO SELLS A BUMP
20 STOCK ON OR AFTER JULY 1, 2023, SHALL BE ASSESSED A CIVIL PENALTY
21 IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND DOLLARS FOR THE
22 FIRST BUMP STOCK SOLD IN VIOLATION OF SECTION 18-12-603 AND FIVE
23 HUNDRED THOUSAND DOLLARS FOR EACH SUBSEQUENT VIOLATION.

24 **SECTION 2. Effective date - applicability.** This act takes effect
25 upon passage and applies to offenses committed on or after said date.

26 **SECTION 3. Safety clause.** The general assembly hereby finds,
27 determines, and declares that this act is necessary for the immediate
28 preservation of the public peace, health, or safety."

29 Page 1, strike lines 101 and 102 and substitute "**CONCERNING**
30 **PROHIBITIONS ON BUMP STOCKS.**".
