

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

SB25-011 be amended as follows:

1 Amend printed bill, page 3, strike lines 20 through 27.

2 Page 4, strike lines 1 through 5 and substitute:

3 "SECTION 2. In Colorado Revised Statutes, 24-33.5-1228, add
4 (2.5)(f) as follows:

5 **24-33.5-1228. Colorado firefighting air corps - creation -**
6 **powers - aircraft acquisitions required - center of excellence -**
7 **unmanned aircraft systems study and pilot program - Colorado**
8 **firefighting air corps fund - creation - report - deployment of**
9 **detection components - rules - definitions.** (2.5) (f) (I) AS USED IN THIS
10 SUBSECTION (2.5)(f), UNLESS THE CONTEXT OTHERWISE REQUIRES:

11 (A) "CAMERA STATION" MEANS ONE OR MORE CAMERAS AND
12 ASSOCIATED HARDWARE THAT ARE CAPABLE OF GENERATING A
13 THREE-HUNDRED-SIXTY-DEGREE PANORAMIC VISUAL FEED AND UTILIZING
14 PAN, TILT, AND TWENTY TIMES OR GREATER ZOOM OPERATIONS.

15 (B) "DETECTION COMPONENT" MEANS AN".

16 Page 4, strike lines 10 through 27 and substitute:

17 "(C) "END USER" MEANS AN INDIVIDUAL WHO IS AUTHORIZED BY
18 A VENDOR AGREEMENT TO HAVE ACCESS TO THE LIVE FEED OF A
19 DETECTION COMPONENT.

20 (D) "FUND" MEANS THE FIRE TECHNOLOGY CASH FUND CREATED
21 IN SUBSECTION (2.5)(f)(IV) OF THIS SECTION.

22 (E) "PRESCRIBED FIRE" HAS THE MEANING SET FORTH IN SECTION
23 29-22.5-102 (7).

24 (F) "VENDOR AGREEMENT" MEANS AN AGREEMENT BETWEEN THE
25 DIVISION AND ONE OR MORE QUALIFIED VENDORS, WHICH AGREEMENT
26 REQUIRES THE VENDOR TO COMMUNICATE TO EACH END USER THE
27 REQUIREMENTS OF SECTION 18-7-801 CONCERNING CRIMINAL INVASION OF
28 PRIVACY, ALLOWS THE STATE TO ALLOCATE RESPONSIBILITY OR RISK TO
29 ONE OR MORE VENDORS TO DEVELOP AND OPERATE A DETECTION
30 COMPONENT, AND DEFINES THE SCOPE OF SUCH RESPONSIBILITY OR RISK.

31 (II) (A) AS NEEDED, THE DIVISION MAY ISSUE A REQUEST FOR
32 QUALIFICATIONS FROM PRIVATE ENTITIES FOR THE PURPOSES OF THIS
33 SECTION. THE REQUEST FOR QUALIFICATIONS MUST SEEK PROPOSALS FOR".

34 Page 5, line 2, strike "PRIVATE PARTNER" and substitute "VENDOR".

35 Page 5, line 4, strike "PRIVATE PARTNER." and substitute "VENDOR.

- 1 (B) THE DIVISION SHALL DEVELOP A LIST OF THE MOST QUALIFIED
2 VENDORS THAT SUBMIT PROPOSALS PURSUANT TO SUBSECTION
3 (2.5)(f)(II)(A) OF THIS SECTION.
- 4 (C) THE DIVISION MAY ESTABLISH VENDOR AGREEMENTS WITH
5 ONE OR MORE OF THE VENDORS THAT SUBMIT PROPOSALS PURSUANT TO
6 SUBSECTION (2.5)(f)(II)(A) OF THIS SECTION."
- 7 Page 5, line 5, strike "(4)" and substitute "(III)".
- 8 Page 5, line 7, strike "(a)" and substitute "(A)".
- 9 Page 5, line 11, strike "(b)" and substitute "(B)".
- 10 Page 5, line 16, strike "(c)" and substitute "(C)".
- 11 Page 5, line 17, strike "(d)" and substitute "(D)".
- 12 Page 5, strike lines 19 through 21 and substitute:
- 13 "(E) ENSURE THAT CONTAINED AND PRESCRIBED FIRES ARE
14 MONITORED APPROPRIATELY;
15 (F) INCLUDE A SOFTWARE INTERFACE FOR FIRE AGENCIES AND".
- 16 Page 5, strike lines 24 and 25 and substitute "CAPABILITY AS WELL AS
17 OTHER NECESSARY MONITORING FUNCTIONALITY; AND
- 18 (G) USE PIXELATION OR ANOTHER BLURRING TECHNOLOGY TO
19 PROTECT THE PRIVACY OF PRIVATELY OWNED, HUMAN-MADE STRUCTURES.
20 (IV) (A) THE FIRE TECHNOLOGY".
- 21 Page 5, strike line 27.
- 22 Page 6, strike line 1.
- 23 Page 6, line 2, strike "OTHER".
- 24 Page 6, strike lines 5 and 6 and substitute "EXPENDED BY THE DIVISION
25 FOR UTILIZATION OF FIRE DETECTION RESPONSE AND MANAGEMENT
26 TECHNOLOGIES, DEPLOYMENT OF DETECTION COMPONENTS THROUGH
27 VENDOR AGREEMENTS, AND UTILIZATION OF TECHNOLOGICAL TOOLS THAT
28 ENABLE ADVANCEMENT IN FIRE DETECTION AND MITIGATION PRACTICES.
29 (B) THE STATE TREASURER SHALL CREDIT ALL INTEREST AND".
- 30 Page 6, line 10, strike "(c)" and substitute "(C)".

- 1 Page 6, line 14 strike "(6)" and substitute "(V)".
- 2 Page 6, strike lines 18 through 27.
- 3 Page 7, strike lines 1 through 11.
